In response to your request for a written statement, I submit the following:

1. Why did you decide to apply to serve on the BOE?

I was called to be part of the large-scale change towards the highest quality public education system in service to our children of Hawai'i. Thus, it becomes a responsibility of mine as kanaka makua to join the community's efforts to build a foundation for their success.

2. How do you perceive the role and responsibilities of individual members and the overall role of BOE in regards to educational decision-making?

As individual board members making educational decisions, we must foremost take responsibility for our collective performance. We do this by a) demonstrating personal humility, b) establishing appropriate rules of engagement, c) fulfilling set board-level fiduciary and strategic responsibilities, and d) being a source of leadership and support to the Superintendent and other key stakeholders for the public school system.

3. Why do you believe you are qualified for this position?

Three of the qualities that will serve me best in this position are:

Strategizing:

The BOE is responsible for developing and protecting a clear, long-term strategic vision for Hawai'i's public schools.

As Chief Executive Officer for the YWCA of O'ahu, I led the revitalization of the agency's community building strategy in an environment of very limited resources to create a more sustainable business model for its mission objectives. Part of this effort included the raising of \$14 million for capital

improvements at three historic facilities and the launch of several new youth development programs including Culinary Arts for Enterprising Youth (CAFE Y), Camp \$tart Up, Life Inc. - career and college exploration program for teens, Youth Advisory Board and Young LeaderLuncheon.

Networking:

Board of Education members must have the ability to function among diverse colleagues as an effective team member with the ability to help shape consensus surrounding board policies.

My constituency building and governance experience includes service on several community boards and committees including Hawai'i Alliance for Non-Profit Organizations (HANO), Aloha United Way, Kamehameha Schools Trustee Selection Committee, The Center for Asian Pacific American Women, Hawai'i Tourism Authority's Hawaiian Cultural Advisory Committee, and Hogan's Entrepreneurs Advisory Board at Chaminade University. I have also actively participated in Youth Matters Network, a statewide network of youth-serving non-profit organizations, to develop youth outcomes and effective program practices to prepare our children for success in life.

Learning:

Board of Education members must have a commitment to education and educational leadership.

I love to learn. In the native Hawaiian language, the word "a'o" is marked appropriately to indicate the reciprocal action of either "to teach" or "to learn". As a continuous learner, I have attended many leadership programs such as Harvard's Executive Educational programs - Strategic Perspectives and Performance Measurements for Non Profit Management, the Native Hawaiian Leadership Academy, and Executives Leading Sustainable Change. I also graduated as 'ōlapa from Hālau Mōhala `Ilima and continue as a student of hula and native Hawaiian language.

As "teacher" at the early age of 13, I created "Peachwood Playschool" to provide an after-school babysitting program for neighborhood children. I have also hosted "Entrepreneurship", a televised course for the Department of Education to educate high school students on self-employment and business plan writing skills. In 2005, I started Women Leading Change-Hawai'i in partnership with the Institute for Women's Leadership to provide leadership training and alumni network to 6 cohorts and over 100 executive women.

4. Please identify one short- and one long-term goal and how you would accomplish during your term of service?

As an appointed member for a one-year term, I would hope to be part of the foundation setting for the longer-term strategic goals and priorities as outlined in the Strategic Plan and Race to the Top application. Part of this foundation setting is the need to build the public's trust and confidence in its newly appointed BOE. Initially, as a Board we can adopt a statement of mutual expectations among board members to enable a cohesive and well-aligned Board. This starts the culture shift that values interdependence and collective accountability necessary for a decentralized school administration and a highly engaged community all focused on greater student achievement.

5. Can you foresee any possible conflicts of interests and how would you overcome them?

I do not foresee any possible conflicts of interests. I would address any potential conflict immediately with full disclosure starting with the Board Chair in order to achieve a timely and appropriate resolution.



4. Because HEM is a parent advocacy organization we would like to hear the candidate's thoughts on enhancing parent and community engagement in our public schools. Does the candidate know of any particularly effective community engagement models that could be

replicated?

HEM was recently named in SCR 145 by Senator Tokuda (a concurrent resolution to develop a statewide parent/community engagement policy) to work with BOE on developing this policy prior to the 2012 legislative session. What does the candidate feel is the role of community and family engagement is in the educational success of the public school student?

I am writing this letter in support of my wife, Cheryl Ka'uhane Lupenui, for a position on the new Board of Education. When my wife first got the call asking if she would consider accepting a board position nomination, she did what she always does when faced with decisions of consequence- she did her homework. Cheryl did a good deal of research combing on-line archives, talking to people who were teachers and students in the public school system, talking to key community leaders and stakeholders to get their feedback, and talking to me to see if the position would be a good fit in our lives. This is the way she approaches questions of such import. What I appreciate about this is she never assumes she knows all there is to know and equips herself as fully as possible before making up her mind. This sort of humility, respect and curiosity has allowed her to gain information and knowledge that I believe she would not otherwise have access to.

Cheryl has always taken her responsibility as a community builder seriously, seeing herself as community leader and community member as well, recognizing that building communities requires leadership that is as understanding as it is strong. She also realizes the need to be a part of a community, be willing to do the necessary work, if one is to ask this same thing of others. She believes there is no more important work than securing the opportunity for a quality educational experience for each and every child in Hawai'i.
