GM 657 Nomination to the Board of Education James D. Williams Responses to Questions

### 1. Why did you decide to apply to serve on the BOE?

The following from my application letter to Governor Abercrombie, dated February 24, 2011, answers this question:

"The Department of Education is now at an important crossroad. With a new system for selecting a Board of Education, we have the opportunity for a new beginning. I believe it is critically important for our students and for the future of our state that we seize this opportunity to dramatically improve the performance of our public schools.

"Since my days teaching on Molokai, first at Kaunakakai School, then at Molokai High and Intermediate, and more recently as developer and co-founder of Voyager Charter School, I have had a strong commitment to our public school system and a passion for finding ways to improve our schools....

"If you accept my application, I will give my full energies to work with you, the other Board members, and the Superintendent of Education to give our community the public school system it deserves."

2. <u>In light of recent changes to the Board's composition, how do you perceive</u> the role and responsibilities of individual members and the overall role of the BOE in regards to educational decision-making?

In my view, the roles and responsibilities of individual members start with the overall role of the BOE, which begins with the Constitution. The Constitution (Article X. Section 3.) provides that "The board of education shall have the power, as provided by law, to formulate statewide educational policy and appoint the superintendent of education as the chief executive officer of the public school system." In addition, Act 5 (2011) provides that each nominee (of our new appointed board) "shall have a clear understanding of the board's role in developing and protecting a clear, long-term strategic vision for Hawaii's public schools, and shall understand the need to hold the superintendent of education accountable for making consistent progress toward that vision." To me, this means that the BOE should focus on policy, including first and foremost a long-term strategic vision, and on appointing the Superintendent and holding the Superintendent (and his/her direct reports who are approved by the Board) accountable for the performance of the DOE.

As an individual member of the Board, I would fully support the focus on policy (including strategic planning) and appointment and oversight of the superintendent as

provided by the Constitution and Act 5. My first job will be to work with my fellow board members to ensure that our organizational structure supports the aforementioned focus on policy and strategic planning. In addition, as the Governor's appointee and given the prevailing sentiment to hold the Governor accountable for improving the performance of our system of education, I believe I have an obligation to listen to and support input from the Governor regarding priorities and strategic direction. Each board member brings different experience and knowledge to the position, and I believe it is my responsibility to apply my unique background and knowledge to help inform the other board members, so that the whole (Board) becomes greater than the sum of the parts in our efforts to guide and support improvements in students' performance.

3. Given your understanding of the role and responsibilities of a member of the BOE, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, experiences, or knowledge that would aid in your decision-making ability as a member of the BOE. Highlight the three qualities you feel make you a highly qualified candidate.

As my career has evolved, I have had the good fortune to hold leadership positions in a number of organizations and gain experience and perspective that will guide me in my service on the Board of Education.

First, as a teacher at Kaunakakai School and Molokai High and Intermediate School, I have been on the front lines of education. As a BOE member, my teaching experience will both inform my decisions on educational policy, and also give me insights into how policy decisions will impact practitioners. Then as a teacher I got involved in the teachers union during its formative years and eventually served as HSTA president for two (2) years. As a union leader, I participated in the collective bargaining process and learned about how the DOE operates at the management level. On the BOE, that knowledge and experience will be invaluable, since by statute the Board is represented in contract negotiations. In addition, as the leader of a 10,000+ (at that time) member organization, I worked with the staff and Board at the top level of one of our State's largest organizations. As directed in Act 5, knowledge of large organizations is one of the qualifications for BOE members. More recently, in a brief stint (last year) as HSTA's Executive Director, I got a "refresher course" on the current state of affairs, including resolution of "furlough Fridays."

After leaving teaching, my career path moved in the direction of the field of health benefits. Executive positions at Hawaii Dental Service and Royal State Group gave me vital and invaluable experience in managing organizations that serve hundreds of thousands of people. Along the way, I learned about computer systems, finance, human resources, and continual quality improvement approaches. That career direction culminated in my service (for 5 years) as Administrator of the Hawaii Employer-Union Health Benefits Trust Fund (EUTF). As Administrator, I worked with a Board evenly divided between employer and union representatives, to serve nearly 200,000 employees, retirees and their families.

As a co-founder and developer of Voyager Public Charter School I have had the opportunity to lead the design and implementation of a school that, with limited resources and while serving a broad spectrum of public school students, has produced excellent results. In addition to addressing the educational program of the school, that effort has meant working on all aspects of school administration, including facilities, finance, safety and collective bargaining. As a BOE member, the experience and knowledge gained with Voyager will enable me to understand the needs of individual schools and the Superintendent's challenges in leading a system with more than 225 schools.

Overall, the three qualities that I believe most impact positively on my ability to serve as a BOE member are my commitment to, experience in, and knowledge of education from several perspectives, my background in collective bargaining from both sides of the table, and my record and reputation of integrity in the various positions I have held.

4. <u>Please identify one short- and one long-term goal you would have as a BOE member and how you would accomplish these during your term of service.</u>

A short-term goal of mine is to establish a policy that the focus of the Department's resources at every level will be on student learning and the teacher-student interaction. Such a policy would guide staff assignments at every level, and ensure that support activities support the primary mission of the DOE (student learning). To accomplish enactment of such a policy would require the support of the Superintendent (who already has spoken to this point) and agreement of my fellow board members, and I believe they would support making such a policy explicit.

A long-term goal of mine would be to revamp the high school program to focus on preparing students for post-secondary activities, including college, apprenticeship programs, and other vocational choices. This would expand and extend current efforts such as the proposed "college and career ready diploma requirements" now under consideration. The basic steps in accomplishing this goal, would be to obtain agreement from my fellow board members and the Superintendent on the importance of this goal, to initiate study of the options available and the approaches used by other jurisdictions both in the U.S. and abroad, and then to develop specific proposals for implementation. Throughout the process, it will be important to involve a broad representation of stakeholders to build support for change and for the final proposals that emerge.

5. Can you foresee any possible conflicts of interests that could arise during your service on the Board of Education? How would you overcome any possible conflicts of interest?

The only possible conflict of interest that I can foresee at this time would be with my position as a member of the Local School Board of Voyager Charter School. Since Voyager is subject to oversight by the Charter School Review Panel, rather than the

Board of Education (although the BOE does appoint the CSRP), I do not believe there is an inherent conflict between service on the BOE and service on the local school board. However, once the confirmation process is complete, I am committed to seeking advice on this issue from the Ethics Commission, and I will abide by that advice. Also, if the Governor requested that I resign from the Voyager Board, I would do so.

In addition to the Voyager Local School Board, I am a member of the board of the Voyager School Foundation, a private non-profit 501(c)(3) foundation. I do not believe that service on a non-profit board presents a conflict; however, I will abide by any ruling on this position also.

Overall, the qualities that I believe most impact on my ability to serve as a BOE member are my commitment to, experience in, and knowledge of education from several perspectives, my background in collective bargaining from both sides of the table, and my record and reputation of integrity in the various positions I have held.

If the Senate confirms my appointment, I will give my full energies to work with Governor Abercrombie, the other Board members, and the Superintendent of Education to give our community the public school system it deserves.

We hope these questions will help the Committee better evaluate the candidate. - 1. Please have the candidate describe his experience with collective bargaining.
- 2. Please have the candidate describe his experience with complex organizations.
- 3. Please have the candidate describe his experience working among diverse colleagues and in developing consensus based policies.
- 4. Because HEM is a parent advocacy organization we would like to hear the candidate's thoughts on enhancing parent and community engagement in our public schools. Does the candidate know of any particularly effective community engagement models that could be replicated?

HEM was recently named in SCR 145 by Senator Tokuda (a concurrent resolution to develop a statewide parent/community engagement policy) to work with BOE on developing this policy prior to the 2012 legislative session. What does the candidate feel is the role of community and family engagement is in the educational success of the public school student?

Chairperson Tokuda and Members of the Committee on Education.

My name is Will Miyake, former deputy director of the Hawaii Government Employees Association. I am submitting testimony as an individual to urge your committee to recommend confirmation of James Williams as a member of the Board of Education to the full Senate.

I have known Jim for over 25 years during his career as an administrator with Royal State Insurance, the Royal State Learning Foundation that created the Voyager Charter School, and as a member and administrator of the Hawaii Employer Union Health Benefits Trust Fund (EUTF).

As a former public school teacher on Molokai and as past president of the Hawaii State Teachers Association, Jim has always been committed to excellence in public education yet is fully aware of the difficulties teachers, administrators and support staff face everyday to provide quality education and a nurturing environment for Hawaii's children. He understands teacher issues and he is the only candidate that has experience in public sector contract negotiations, contract administration, and public employee rights and benefits. Such first hand knowledge can help the Board of Education as it defines its objectives to improve academic performance in light of the limited human and financial resources available.

As the head of the Royal State Learning Foundation, Jim worked tirelessly with selected public schools on Kauai and Oahu to provide teachers new educational methods and techniques to improve their teaching skills. Over 1,000 public school teachers were trained during his stewardship. Those same teaching methods are used by the Voyager Charter School in Honolulu that he helped create. In 2004 he was hired as its administrator after the previous administrator relocated to the mainland. For someone with Jim's background in labor to be hired by the EUTF Board was no easy

feat considering it required the majority approval of both the employer and union trustees. Even though he represented union employees, he won the respect of the employer for his fairness and objectivity during his service on the Board. He performed admirably as the administrator until his retirement in 2009. Besides having valuable experience in health benefit administration, he understands the complexity of the State budget and legislative process and is realistic as to what is achievable and what is not. However, Jim is not afraid to fight for what is right, even if it may seem unpopular to many.
