Coralie Chun Matayoshi (GM 663) University of Hawaii Board of Regents Senate Education Committee Request for Information

1. Why I applied to serve on UH Board of Regents

I was born and raised in Hawaii to parents too poor to attend college. Their parents emigrated from China, and being the eldest children in their families, they worked to put their younger siblings through college. With hard work, sacrifice and determination, they overcame their humble beginnings and gave their 4 daughters, including me, the most precious gifts of all: a loving home, high hopes and expectations, and a top notch education.

These are the values that I have been brought up with, live by, and apply to everything I undertake. I am not afraid of hard work, enjoy new challenges, and have always left an organization in better shape than when I first started.

I attended UH Manoa for 2-1/2 years and graduated *magna cum laude* from the University of California Berkeley with a political science degree. After receiving my juris doctor degree from Hastings College of the Law, I served 3 years as a Trial Attorney with the U.S. Department of Justice Antitrust Division in Washington D.C., and then came home to practice law in Hawaii at a private firm. Thereafter, I became Executive Director of the Hawaii Institute for Continuing Education, Executive Director of the Hawaii State Bar Association, and now CEO of the American Red Cross, Hawaii State Chapter.

My legal training and dispute resolution experience has given me the ability to spot and analyze issues from all sides. As a Mediator, I assisted parties in articulating their interests and attempting to reach common ground. Serving as an Arbitrator for the Judiciary and Better Business Bureau entailed objective, impartial, decisive decision-making. Once given adequate information upon which to make a decision, I am very comfortable making decisions. However, I prefer to work collaboratively with all stakeholders to arrive at a decision that makes sense for everyone involved.

I have been a volunteer and have worked with volunteers all of my life. As a youth, I was constantly involved in church projects and worked with students at the Hawaii School for the Deaf & Blind as part of my high school Service Club. I have served as a mediator and Board member of the Neighborhood Justice Center, KHON-TV 2 Action Line Board member, Hawaii Bar Journal editor, AUW non-profit sector Campaign Chair, Diamond Head Theater Advisory Board member, and Hastings law school Alumni Association Board of Governors. I have also overseen the work of thousands of volunteers over the past 25 years and have dedicated my life to public service. I know what it's like and what it takes to motivate people to serve.

I have been blessed with many opportunities to contribute to society and believe that I possess the background, education, experience, and passion to make a significant contribution to the University of Hawaii by serving on its Board of Regents.

2. Roles and responsibilities of individual Regents and Board as a whole

The role of the Board of Regents is to formulate policies and objectives for the University of Hawaii and to provide the means by which to accomplish these objectives through a budget and oversight of the internal structure, management and operation of the University.

Individual Regents need to make well reasoned decisions based on the best interests of the University, and not concern themselves directly with the administration of the University.

3. Short term goal - bridge "Town & Gown" through community partnerships

Innovative community partnerships between UH, business, government and nonprofits can harness the collective energies and strength of all partners to tackle complex social problems, give students practical experience and exposure to the real world, provide un-paid assistance (for academic credit) to business, government and non-profit partners, build a base of future volunteers, produce a future workforce that is cognizant of the needs of the public, and create trust, goodwill, buy-in, and financial support for UH from the community.

The UH School of Social Work has a practicum requirement for all BSW and MSW students. The Hawaii Red Cross currently has 5 social work students interning for academic credit. They are doing community disaster preparedness outreach, disaster response, and case work follow up with military families in times of crisis. This is meaningful work that not only helps us fulfill our mission, but gives the students a chance to shape their choice of career. The following is a quote from two of the students:

"The start of my journey as a Social Worker has taken place through interning at the American Red Cross. My social work background has been very minimal up until now. Walking into this placement a year ago, I do not believe I am the same person walking out. The spectrum of skills and experiences that I was able to gain with the Red Cross, has allowed me to develop a better understanding of Micro and Mezzo level practice. This includes providing Mental Health crisis counseling and client case work as a member on the Disaster Action Team, to establishing new partnerships with community leaders in becoming Disaster Red Cross Emergency Shelters. It has been a rewarding and humbling opportunity that has helped me grow as a professional and individual."

* * * *

"I wanted to share with you that my year and a half here at the Hawaii Red Cross as a practicum student has provided me with enriching opportunities to experience a different yet growing field of social work. Disaster mental health professionals have become as essential as registered nurses post-disaster and it has opened my options to yet another area of social work. My experiences on the Disaster Action Team and Casework follow-up has sparked an interest for me to continue to be a Red Cross volunteer beyond finishing my practicum time here. Being at the Red Cross has also motivated me to continue into the MSW program to be qualified as a mental health volunteer and to possibly obtain a career as a social worker in the area of disaster."

When I was an undergraduate student at UC Berkeley as a political science/ pre-law major, I received credits for working at a public interest law firm in San Francisco. At my alma mater Hastings law school, students are given the opportunity to work at legal clinics that serve the poor and disadvantaged.

My daughter just graduated from Santa Clara University with an undergraduate degree in Psychology, and she earned degree credits for field placements at a homeless shelter, Easter Seals, and pre-school for underprivileged children.

These kinds of internships not only benefit society, but expose students to real world experience so necessary for their academic and emotional growth. It also builds a sense of community between "town and gown" and generates invaluable support (e.g. financial, in-kind, political) for UH.

Long term goal – increase online education and transform the way students learn

Technology can help transcend time and distance to enable student-centered learning that offers motivating content and allows students to advance at their own pace while staying connected with their teachers and peers.

Imagine students learning from the best, most authoritative and engaging professors no matter where they reside. Students could access lectures any time of night or day, repeat the parts they don't understand, and e-mail questions to a UH professor or teaching assistant. In person classroom meetings would reinforce the online learning through lively discussion and mentoring by UH educators.

As Executive Director of the Hawaii Institute for Continuing Legal Education, I utilized the University of Hawaii's HITS system 23 years ago to bring live educational courses to neighbor island attorneys. At the Red Cross, we are offering online CPR and Nurse Aid training for the lecture and written test portions of the course which allows us to cut instructor costs and need for dedicated classroom space. Students only need a few hours of live instruction for the skills training and certification part of the course.

Online learning and testing, coupled with engaging classroom discussion would not only allow students to learn from the best at their own pace, but decrease costs (lecture personnel and classroom space) and allow UH educators to focus on mentoring, inspiring, and helping students apply their learned knowledge to the real world.

4. **Possible conflicts of interest**

My husband Ron Matayoshi is the Director of Practicum/Director of International Programs at UH School of Social Work and is tenured with 21 years of service. My son is a second year student at the UH Richardson School of Law. If a matter came before the Board of Regents which involved the School of Social Work or Law, I would disclose my relationship or interest, consult with General Counsel, and recuse myself from the decision if there was an actual or appearance of conflict.

Another potential conflict is that my position as CEO of the American Red Cross, Hawaii State Chapter involves fundraising. If the Red Cross and UH were cultivating the same donor, I would let others approach them on behalf of UH.

5. UH Strategic Plan & Goals

Over the past 23 years, I have successfully led three statewide non-profit organizations with volunteer Boards and throughout that time, have been actively engaged in designing, marketing, and presenting educational programs.

I am most interested in our core commitments to Educational Effectiveness, Economic Development, and Technology. My thoughts are included in responses to Question #3 above.

<u>Educational Effectiveness</u> – currently, only 50% of UH freshman get degrees within 6 years. This represents a tremendous loss of investment in students who lose the opportunity to reach their full potential. Students need real life experience to make career choices, mentoring by community partners who have an interest in the future workforce, freedom to pursue interdisciplinary studies, and even study abroad. Participation by businesses, government and non-profits creates buy-in and support for UH and builds a sense of community between "town and gown."

<u>Economic Development</u> – we need to educate a highly skilled flexible world-class labor force and engage them in helping to solve social problems. By strengthening public and private partnerships, we can produce entrepreneurs with a social conscience who will achieve personal and financial success and give back to the community at the same time.

<u>Technology</u> - technology can help transcend time and distance to enable student-centered learning that offers motivating content and allows students to advance at their own pace while staying connected with their teachers and peers.

6. Budget

At this time, I am not yet familiar enough with UH's budget to suggest specific cost cutting measures. However, as explained above in my response to Question #3, bridging "town & gown" through community partnerships will bring more support and "buy in" for UH from business, government, and non-profits. And, as explained above in response to Question #3, increasing online education and transforming the way students learn will not only allow students to learn from the best at their own pace, but decrease costs (lecture personnel and classroom space) and allow UH educators to focus on mentoring, inspiring, and helping students apply their learned knowledge to the real world.

I have a proven track record in helping to turn organizations around financially.

- As Executive Director of the Hawaii Institute for Continuing Legal Education (HICLE), I started with a nearly bankrupt educational organization that had no staff, no courses planned, \$50,000 in debts, a disinterested Board of Directors, and little support from the legal community. I used my innate sense of creativity, entrepreneurship, and financial savvy to create a well respected, financially successful organization by creating partnerships with other organizations in the community and inspiring volunteer lawyers and judges to spend thousands of hours teaching classes and writing practice manuals to improve the competency of the legal profession. When I left HICLE to run the Bar Association 3 years later, HICLE had \$150,000 in reserves.
- As Executive Director of the Hawaii State Bar Association, I led the sweeping transition from a voluntary to Supreme Court mandated organization. Through careful budgeting, creative non-dues revenue generation and prudent spending, we were able to keep member dues at the same level for over a decade. I started at HSBA with little reserves and left the organization with \$1 million in reserves after rebating \$225,000 to our members.
- As CEO of the American Red Cross, I oversee the statewide delivery of humanitarian services through 9 offices (headquarters, 4 neighbor islands, 4 military centers), 90 full and part-time employees, 4,000 volunteers, and a \$5 million budget. Just before I came on board, they had just let go 7 out of 45 full-time employees, and I started with a \$200,000 deficit budget. My Board and I were able to pull together business and community support to end my first year at the Red Cross with a \$350,000 surplus. When I started with the Red Cross 7 years ago we had \$2.8 million in

assets and \$570,000 in cash; we now have \$10.8 million in assets and \$4.4 million in cash. We also raised \$5 million to renovate our 35 year old facility (including \$3 million from the State Legislature and City Council) and recently obtained a \$240,000 federal appropriation to install photovoltaic panels at our headquarters building to supply clean renewable energy and reduce our operating costs by at least \$20,000 per year for the next 25 years.

7. Ten-Campus System

I support UH's attempt to capitalize on the strengths of each of the 10 campuses and create synergy between them to create an integrated system of higher education. The recent implementation of automatic admission and credit transfer between campuses provides seamless flexibility for students and improves the chances that they will graduate on time. UH should operate as a whole, with maximum efficiencies in operation. Duplication should be eliminated and academic standards uniform to the extent that community colleges serve as feeder schools to UH Manoa, Technology can be utilized to a greater extent to make courses available at all campuses and enable students to graduate on time.

8. Relationship between UH and Legislature

UH and the Legislature need to have open communication, with needs and wants of both parties put on the table. The Legislative and Executive branches should guide the direction of the State and articulate areas of need and plans for job creation. UH should help fill these needs with programs and graduates in those areas. Together, the UH and Legislature can create higher paying jobs and fill these jobs with its own well educated and prepared workforce.

9. Closing Remarks

I owe much to the University of Hawaii - not only did I receive a great education, but I met my future husband and made lifelong friends through Beta Beta Gamma Sorority. I have fond memories of running from my World Civilization class at Varsity Theater all the way to French class at Moore Hall, pledging for my sorority, intramural sports, Homecoming, and rushing to work after class (I was a full-time student working full-time as a flight attendant for Aloha Airlines while serving as Vice President of my sorority and Narcissus Queen). No, I didn't get much sleep, but I did learn to budget my time, which came in awfully handy later on in balancing the demands of career and family.

I look forward to using my energy, passion and talents to help make the University of Hawaii the best it can be for future generations.

I am Gerald A. Sumida, a partner of the Hawai'i-based law firm of Carlsmith Ball LLP, and am very pleased to present this testimony in very strong support of the confirmation of Coralie Chun Matayoshi to the Board of Regents of the University of Hawai'i.

I have worked very closely with Coralie for many years, most recently from the time when she became the Chief Executive Officer of the American Red Cross-Hawai'i State Chapter.
