Dear Senator Tokuda and Members of the Committee:

This letter is being submitted in response to the following questions that were forwarded:

(1) Why did you decide to apply to serve on the BOR?

I decided to apply to serve as a Regent because I believe that I can bring diversity and a unique viewpoint to the Board. For the last ten years, I have been operating and managing the growth and development of an engineering and high tech company in Hawai'i. Prior to this I was the Director of Planning and Permitting at the City, and earlier on was a land use attorney that worked in the area of real estate and development.

Ten years ago, I made a personal decision to change careers. My children are very smart kids - my son is a physics major and my daughter is an engineering major. Ten years ago, I looked around and saw that our State economy was primarily comprised of tourism, military, construction and service related jobs. While these are great industries, they do not represent the jobs of the future, and the hope of my children. I asked myself whether we were inspiring our local kids to pursue STEM careers, only to become educated and to move to the mainland in order to find good jobs. While it is a daunting task, I felt it was a worthwhile mission to work to grow a new economic sector for the State – a true high tech sector.

While there is no exact "model" that matches Hawaii's unique situation, it is very clear that any State that has built a healthy tech sector has also built a strong University that recognizes the importance of this industry. I decided to apply to serve as a Regent because I believe that the University plays a critical role in developing a new economy for Hawaii's future.

(2) What do you perceive are the roles and responsibilities of individual members and the overall role of the BOR in regards to University decision-making?

The Board's constitutional role is to hire and fire the President, to set policy, and to have jurisdiction over the University's internal structure, management and operations. I believe that the Board should focus its time on issues that are significant and that have long term consequences. A good board will be comprised of individuals that will bring diverse experiences and viewpoints to any discussion. A healthy board will be willing to ask hard questions and have thorough discussions with the intent of achieving solid, well thought through decisions. I believe that individual board members have a duty to act in the best interest of the University, and in a manner that is consistent with the University's mission and goals.

(3) Please identify one short- and one long-term goal you would have as a BOR member and how you would accomplish these during your term of service.

One short term goal would be to implement HiTex (Hawai'i Innovation Technology Exchange Institute), or some version of this institute. This goal was one of the key recommendations that were contained in the report from the President's Advisory Council on Hawai'i Innovation and Technology Advancement. I would hope to support the President's initiative in this area through instituting the necessary organizational and policy changes that will be required.

One long term goal would be to support the President's far-reaching initiative to create a 21st century capability for innovation and technology transfer to support the development of a tech industry for Hawaii. Specifically, I would like to focus on the initiative to integrate entrepreneurship and innovation into the curriculum. These skills are critical to building a workforce that can compete in the 21st

> century. Because entrepreneurship and innovation require collaboration and inter-disciplinary discourse, established policies, practices and structures that have led to departmental or individual college "silos" will need to be reviewed and creative approaches will need to be explored and adopted.

(4) Can you foresee any possible conflicts of interests that could arise during your service on the BOR? How would you overcome any possible conflicts of interest?

Oceanit is an engineering and high tech company. The company has never, to my knowledge, participated in engineering work for the University. The company has on occasion contracted with the University to do joint research, and to hire student and/or graduate student interns. Oceanit's business model makes the prospect of licensing from the University unlikely, as the company's strength has been in its own strong R&D capabilities, and its deep intellectual property portfolio.

In the unlikely event that there was a conflict of interest, I would recuse myself from any decision making or discussion surrounding the matter.

(5) In looking at the University's strategic plan and the goals laid out by President Greenwood for the University system, what particular areas are of interest to you and how will your particular skill set and experience contribute to the progress of the University system.

Some of this question has already been answered under Question (3), above.

My areas of relevant experience include:

- Short and long range planning. This includes physical facility planning and development, as well as broader policy planning that establishes measurable targets;
- Operational and CIP budget planning and prioritization;
- Forward looking entrepreneurial and innovation programs and initiatives;
- Working with and understanding complex funding sources including federal grant funding.

(6) We are currently faced with an unprecedented budget crisis. What ideas do you have for generating revenue or cutting costs for the University and how should the University go about making any cuts within the budget?

One area to consider would be to build strong federal grant programs in research areas that are aligned with the University's growth mission. Given the current state of the federal budget and the difficulties in pursuing traditional sources of congressional support, it is an ideal time for the University to support and build strong faculty research in targeted areas, and to capture federal grant monies through competitive award processes.

I need to spend more time familiarizing myself with the University's budget in order to properly answer the budget cut question. In general, I think that in an ideal world, departments or colleges would build an operating and a CIP budget and would submit it to the President's office for review, analysis and prioritization. Because the University is so diverse and its funding is so complex, this is probably a difficult goal to achieve. When money is tight, all businesses that manage to stay in business know that in order to keep the doors open and keep a business moving forward, you must go through the difficult decision making process of prioritizing. While it is easier to do across the board cuts, in my opinion, the ideal way to approach a reduction is to clearly connect funding to priorities.

(7) How do you view the role of the system as it relates to the 10 campuses? Do you feel that the relationship as it exists now should be changed? How will you ensure equity of resources across all campuses?

I need to learn more about the University system in order to properly answer this question. However, the following provides a general answer. I would assume that in a difficult economy, there will be an increase in enrollment in the community colleges. Also, since the tuition base is lower at community colleges, the subsidy per student is probably higher. If this is correct, then a thoughtful allocation cannot be based solely on enrollment percentages, as the allocation will always favor the UH Manoa campus. Ideally, the University should operate as an integrated "system", not as completely disparate units, and resource allocation should be based on larger system-wide goals and priorities.

(8) While the University enjoys a fair amount of autonomy, the Legislature still plays a significant role in regards to funding, policies and procedures. How do you view the relationship between the University and the Legislature and what factors are critical to ensure an effective and collaborative relationship?

The University still relies significantly upon the Legislature for its funding. As a public University with the mission of providing an affordable education to local kids, it will always need to rely upon taxpayer funds to some extent. In my opinion, autonomy and accountability go hand in hand. If money is being allocated and spent, then a proper accounting of that money should be communicated in a clear and straightforward manner to the funder.

The most important element in a good relationship of any kind is communication. To this end, I would support strengthening a predictable and transparent method of providing information, and in maintaining good lines of communication.

The questions that you have provided are very thoughtful, and I appreciate the opportunity to share my views on these matters.

I have known Jan Sullivan since 1991, when she was in private practice at Takeyama & Sullivan and I was an attorney at Fujiyama, Duffy & Fujiyama. I worked with her on a number of real estate development projects and was impressed with her intelligence, expertise, and ability to get things done. Despite her youth, she had already earned an excellent reputation as a real estate lawyer. I was not surprised to see that the Mayor of the City & County of Honolulu appointed her as Director of the Department of Planning and Permitting.
