Mr. Minatoya currently serves as the Deputy Prosecuting Attorney and Supervisor of the Appellate and Asset Forfeiture Division of the Maui Department of Prosecuting Attorney where he handles criminal appellate cases to the State appellate courts, Hawaii Rules of Penal Procedure Rule 40 petitions, federal *habeas* cases and appeals, and asset forfeiture matters before the State Attorney General and circuit courts. He previously served as the Deputy Corporation Counsel to the County of Maui, the First Deputy Prosecuting Attorney for the Office of the Prosecuting Attorney for the County of Kauai, and as an elected Councilmember for the County of Kauai.

Mr. Minatoya attended Kauai High School and graduated from the University of Southern California (USC) with a Bachelor of Arts degree in economics. He received a Juris Doctor degree from the William S. Richardson School of Law at the University of Hawaii at Manoa in 1992. Mr. Minatoya also finds the time to devote to community service, serving on the Boards of Directors for the Kiwanis Club of Kahului, USC Hawaii Alumni Club, and the Wailuku Hongwanji Mission.

Considering his extensive experience, accomplishments, and passionate commitment to public and community service, I am confident that if given the
