Re: Hawaii Medical Education Council, GM 697

I am Arthur A. Ushijima, President & CEO of The Queen's Health Systems and President of The Queen's Medical Center. I have applied to be re-appointed to the Council because Hawaii and the nation are facing a significant and growing shortage of physicians. As demand for healthcare services increases with the aging population, the state may not have an adequate supply of physicians to support this need. I have been involved with graduate medical education since 1980 and feel that my thirty years of experience may useful and helpful in addressing this issue.

Besides my experience in the development and management of graduate medical education programs, I have worked with the medical staffs of five different hospitals in five different states since 1973. I have had experiences in governmental, faith-based and community hospital settings, working with physicians in academic, private and employed practice models. I have experienced the changing requirements of medical practice over the past thirty-eight years and anticipate that the Patient Protection Affordable Care Act will dramatically change the landscape of medical practice and healthcare delivery over its implementation. Having had experiences with the evolution of Medicare since 1973, I may be able to productively contribute to the development of medical practice under the Affordable Care Act.

We must develop a continuum of programs in graduate medical education in order to encourage graduating medical students to remain in Hawaii for training and practice. It is important to develop fellowships in needed specialties such as gastroenterology; oncology, as well as to increase the number of primary care physicians. In 2009, Queen's working with the John A. Burns School of Medicine developed an ACGME-approved fellowship program in cardiology to address the need for cardiologists. We must encourage partnerships between UH and the private sector to promote growth in physician supply. There are several things that merit some consideration:

- 1. Provide tax credits to individuals who provide support to graduate medical education at the University of Hawaii.
- 2. Create incentives to medical students to enter needed specialties such as primary care; internal medicine and who establish practice in Hawaii.

- 3. Provide incentives such as tax credits for malpractice premiums for physicians willing to provide ER call coverage.
- 4. Address physician concerns over malpractice.
- 5. Develop physician extender programs such as physician assistants; advanced practice RN's. GME programs will not likely be able to train enough physicians to meet demand.

With the current federal budget issues and not having enough resources to train physicians and other health professionals, we can expect shortages to grow. We will need to collaborate and create partnerships to increase physician and care-giver supply.

Because I am employed by Queen's, it's possible that conflict-of-interest situations could arise and I will recuse myself when situations occur.
