Why do you wish to be a commissioner of HCNCS?

When discussing the possibility of being recommended for a position on a board or commission, with the head of the Boards and Commissions office, I indicated that I wished for a placement where I would be able to genuinely help people and utilize the knowledge and experience I gained through my career in counseling and guidance, and studying for my PHD in educational policy from the University of Hawaii. Using my existing familiarity with the program, additional information gained though research and informal interviews with two former program workers, I am convinced that this commissioner position would extremely suitable for me. I believe that I can help make a difference in people's lives, through this program.

The fundamental mission of HCNCS is to recruit residents of all ages and backgrounds to engage in community service in the areas of public safety, education, literacy, environment, and basic human needs. How do you perceive our role and responsibilities as a commissioner of HCNCS?

Those that know me understand that *I am a true advocate* of issues, people and programs that I truly believe in. As an advocate for HCNCS, I would assess the individual programs and look for suitable aspects and benefits attractive to potential recruits. Qualified individuals on different life plans and predicaments would be made aware of various characteristics or benefits of the program and encouraged to participate. Suitability is important to success.

Given your understanding of the role and responsibilities as a commissioner of HCNCS, why would you believe that you are qualified for the position? Please include a brief statement of our skills, expertise, experiences, or knowledge that would aid in your decision-making ability as a commissioner. Highlight the three qualities you feel make you a highly qualified candidate.

Among my roles as a commissioner would be one involving *research and evaluation*. I am very familiar with *initiating and assessing research*, including evidence based programs. If I enter a realm less familiar, I know where to seek assistance.

I have spent my working life as a school counselor and advocate for students and their families; from the richest to the poorest. In those roles, I have *empathy* for, have assisted those in need and thoroughly *enjoy* their successes.

As a *grant writer* and *project manager*, I am able to carry on projects to completion. I am open to new evidence and advice from others and am comfortable with what new evidence brings, whether that be *endorsing, tweaking or eliminating* the plan or process.

What would be our top three priorities for HCNCS?

Recruitment of qualified individuals to work in the appropriate programs. *Assignment* of qualified individuals to *appropriate* positions. Ongoing *training* and continuing *support* for volunteers throughout their tenure and into their post-volunteer life.

What impact do you think the current economic recession will have on volunteerism and what challenges and/or opportunities will the commission face during these times of economic uncertainty?

There is evidence that during a recession that many individuals return to higher education. It may be possible to recruit from amongst these individuals some that would benefit from association with HCNCS.

Recession may also mean reduced available funding. This possibility may result in HCNCS paying additional attention to methodology required to generate additional resources.

Can you foresee any possible conflicts of interests that could arise during your service on the HCNCS? How would you overcome any possible conflicts of interest?

Hawaii is a small state. Many people know each other through work, school or association. If a conflict of interest develops, I would immediately acknowledge it/elevate it and follow recommendations discussed for remediation. That may mean extracting myself from the particular situation that warrants consideration.
