To the Senate Committee on Education:

Thank you very much for considering me as a candidate for the Hawaii Commission for National & Community Service. Please see my responses to your questions below:

- 1. Why do you with to be a commissioner of HCNCS? I view this as a good opportunity to help strengthen Hawaii's community as a whole, with a particular emphasis on education. I am a product of the Hawaii State Public School System and feel that my skills can be of use in the planning and allocation of resources to benefit our community.
- 2. The fundamental mission of HCNCS is to recruit residents of all ages and backgrounds to engage in community service in the areas of public safety, education literacy, environment, and basic human needs. How do you perceive your role and responsibilities as a commissioner of HCNCS? I feel that I can provide a "private sector" perspective on resource allocation and prioritization. Having been educated in Hawaii's public school system and a mainland private college, I have a good feel for various educational philosophies. In addition, my current employment in the private sector working with small businesses keeps me "in tune" with the local economy.
- 3. Given your understanding of the role and responsibilities as a commissioner of HCNCS, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, experiences, or knowledge that would aid in your decision-making ability as a commissioner. Highlight the three qualities you feel make you a highly qualified candidate.
 - a. Private sector experience. Having worked in the private sector (and specifically with small businesses for the last 8 ½ years) provides me with the opportunity to observe and counsel small and medium sized businesses in making important decisions with regards to resource allocation and prioritization. This expertise can be directly translated to decision-making situations as a commissioner.
 - b. Education and work experience. My economics and MBA degrees, along with the work experience in the financial services industry (banking, insurance, and investments) has provided me first-hand experience with regards to financial analysis, budgeting, and credit decisions.
 - c. Teamwork, sales, and customer service. My sports background and work experience have given me a solid understanding of the benefits of working together effectively in teams. In addition, sales and customer service experience has helped me view situations from different perspectives, which helps in negotiation and effective communication.

- 4. What would be your top three priorities for HCNCS?
 - a. 1) Ensure fiscal responsibility and effective resource management.
 - b. 2) Help strengthen Hawaii's communities through the implementation of various programs benefiting education, safety, environmental conservation, and other civic & social service needs.
 - c. 3) Help increase the awareness of the need, benefits, and impact of volunteerism in our community. It doesn't take much but if everyone contributed a little of what they have (money, time, etc.), it can make a huge difference in our communities.
- 5. What impact do you think the current economic recession will have on volunteerism and what challenges and/or opportunities will the commission face during these times of economic uncertainty? I believe the current recession will have a huge impact on all aspects of our communities. The unemployment and under-employment situation has and will continue to increase the need for social & civic service organizations to enhance the level and volume of services they provide. However, their ability to do so will likely be offset by a loss of resources in terms of both funding and manpower. This will particularly impact organizations that are primarily funded by grants or donations, both of which will be negatively affected by spending cuts in both the public and private sectors. As such, services provided by volunteers will increasingly be relied upon to fill service gaps in all areas. This poses an opportunity for organizations like HCNCS to promote the benefits and significant impact of volunteerism.
- 6. Can you foresee any possible conflicts of interests that could arise during your service on the HCNCS? How would you overcome any possible conflicts of interest? The only conflict I can see is if I am required (as a commissioner) to publicly endorse any political position or candidate as I would not want that to create tension or conflict with any of my clients or colleagues. As such, I will try to remove myself from any situations in which this might occur.
