Honorable Chair and Members:

This firm has represented public sector unions and employees at the HLRB since the Board's inception in 1971. We have ancient cases bearing single digit serial numbers, whereas they are now up to half a thousand. I personally began working on Board issues in 1978 as a law clerk, and the bulk of my practice for thirty years has involved the Board. During that time I believe I've argued to, or studied the decisions of, most of the Board members who have ever served. If I missed one, it surely wasn't for lack of enthusiasm for filing cases!

Mr. Ley in my relationship with him over the past six years has demonstrated the finest character, honesty and a keen and curious intellect.


