Chair Espero, Vice Chair Kidani, and Members of the Committee:

The Department of Public Safety (PSD) strongly supports the nomination of Bert Y. Matsuoka as Chair of the Hawaii Paroling Authority. Mr. Matsuoka's background and experiences speak well of his ability to represent diverse members of the community.

As this Committee is aware, Governor Neil Abercrombie is in strong support of returning home Hawaii inmates placed out-of-state. The Department is working on a two-prong approach to achieve this: 1) develop and implement a comprehensive reentry plan that will expand and improve in-facility and community-based programs to prepare inmates for successful reintegration into the community; and 2) expand instate capacity. The Hawaii Paroling Authority is an integral part of the re-entry process and Mr. Matsuoka is very willing to participate in developing a system that

promotes public safety through effective and evidenced-based programs for transitioning inmates.

Beginning his career as a metropolitan police officer with the Honolulu Police

Department, Mr. Matsuoka moved to state service in 1980 as an investigator with the

Department of Human Services (DHS) welfare division and was quickly promoted to

manage the Restitution Control Section where he coordinated and conducted criminal
and administrative investigations. In 1992, Mr. Matsuoka took advantage of an

opportunity to administer the DHS Volunteer Services Office where he was active in
many community events that introduced him to volunteers from all walks of life. In

1993, he joined the Office of Youth Services as the Youth Gang Project Coordinator
and in January 1995 was appointed the OYS Executive Director by then Governor

Ben Cayatano. As Executive Director, Mr. Matsuoka worked intimately with over 50

community-based organizations that provided services to children and youth. He was
respected for his collaborative endeavors with the community, including advocating
for and initiating new opportunities for Hawaii's opio.

As a Hawaii Department of Defense civil defense planner, during emergency events and activities Mr. Matsuoka was responsible for planning and coordinating with the myriad of agencies, both public and private, which are first responders.

Again, this required he draw on his ability to effectively collaborate with others and ensure protection of the public during civil defense emergencies.

Mr. Matsuoka is a member of the U.S. Coast Guard Auxiliary and a board member of the Moiliili Hongwanji Mission, in addition to participating in community services projects in East Honolulu.

Senator Espero, Senator Kidani, and Members of the Committee:

I am providing testimony in support of the nomination and confirmation of Mr. Bert Y. Matsuoka as Chairman of the Hawaii Paroling Authority (HPA).

As the Paroles and Pardons Administrator of the Hawaii Paroling Authority, I have worked very closely with Mr. Matsuoka on a number of issues such as recent court decisions that affect the parole board's decision making process when fixing minimum terms of imprisonment, parole consideration and parole revocations, and policies and procedures. Dear Senator Espero:

This is in response to your letter dated April 12, 2011 requesting information regarding my nomination to the Hawaii Paroling Authority (HPA) by Governor Neil Abercrombie.

I would like to preface my response by expressing my appreciation to Governor Abercrombie and the selection panel for their confidence and support in my nomination for this position.

I also want to thank Jodie Maesaka-Hirata, Director of the Department of Public Safety for her support in the nomination process and fellow nominees Judge Michael Town and Joyce Matsumori-Hoshijo for their good wishes.

The following are my responses your questions:

#### 1. Why do you wish to be a member of the Hawaii Paroling Authority?

I have over 30 years of public service; many of those years were spent either in criminal justice or juvenile justice related positions. Those are the two areas that I have a lot of personal commitment and interest in. The HPA plays a critical role in our community's well-being, and with my experience, I believe I can further contribute by making sound parole decisions and also help guide the HPA to become an even more effective and efficient agency.

## 2. How do you perceive the role and responsibilities of a member of the Hawaii Paroling Authority?

The HPA deals with a very small segment of the State's total population. However, the population that comes into contact with the HPA is made up of individuals who possess a high impact status within our community. These individuals have committed serious law violations and have been committed to incarceration for their crimes.

The HPA is tasked to determine if and when these individuals are allowed to transition back into the community without posing a risk to public safety or to the individuals themselves. HPA board members need to take a careful, objective view of each individual and determine whether he/she is prepared to be afforded an opportunity to be allowed back into the community.

# 3. Given your understanding of the role and responsibilities of a member of the Hawaii Paroling Authority, why do you believe that you are qualified for the position?

I feel that my experience and character allows me to view situations in an objective manner. With regard to the specific situations facing the Parole Board, I think I can bring a balanced approach in determining decisions. I believe my law enforcement experience coupled with my social services background will allow me to view a situation with minimum bias. I will place emphasis on the collected research, data, and history of the individual, and seek the input from the professionals who actually work with and are familiar with the individual.

I also believe that I won't be intimidated by either the inmate or the establishment in making decisions. I feel that when decisions are based on accurate information, established "best practices," and clear objective views, you will have the most appropriate and responsible outcomes possible.

However, I need to note that when attempting to predict human behavior, especially those who have had a troubled past, this process is far from being an exact science.

#### 4. What do you hope to accomplish during your term of service?

Having been the interim Chairperson now for almost two months, I have observed the good work done by the HPA. These are very dedicated and committed professionals who strive to maintain the high standards required of the HPA.

If afforded the opportunity, I want to help the HPA to positively move forward. I will work collaboratively with all segments of the staff and look at where we can strengthen and improve the agency. I believe this can be accomplished with good communication and networking, not just within the HPA, but reaching out to other entities that have a part in the whole parole process.

The whole "process of parole" needs to be recognized as complex and multi-faceted. I believe improvement in the parole process cannot occur with just the HPA operating alone. Positive strides will occur when there are more working partnerships with the Department of Public Safety, other government agencies, non-profit organizations, and community groups all contributing and sharing in this endeavor.

With the assistance of the other Board members, and the staff of the HPA, I believe that we can begin the movement in this direction.
