Hawai'i's recidivism rate has exploded from the country's lowest at 5% in 1973¹ to one of the nation's highest at 54.6% in 2009.²

I have known Michael Town professionally since 1994 when I began representing indigent youth and adults, and was a public health master's degree student learning about rehabilitation, and he was senior judge for the Family Court. Formerly, I was a deputy attorney general who did some prosecution work and represented the state and agencies including the department of public safety.

Michael Town's vision and leadership skills have been instrumental in working to decrease criminal recidivism. He has promoted both restorative and therapeutic justice (what drug & other specialty courts are based on), which are two foremost rehabilitation strategies today in criminal justice.

Judge Town has been one of Hawai'i's biggest supporters of rehabilitation for people involved with the justice system. He has enthusiastically supported the *Huikahi Restorative Circles*, a reentry planning process for individual incarcerated people and their loved ones, which has gained national as well as international attention. At least eight articles have been published about the program, two by the United States Courts. A book on the process is in press. Research shows that this simple and inexpensive process brings healing to traumatized families and promise to decrease criminal recidivism.

Retired Judge Town would provide rehabilitation innovation for our parole board. Clearly we need people with expertise on rehabilitation to serve our parole board.

I know my daughter, Mia Town, and son, Gaylord Town, and other family members and supporters will be present and possibly submitting testimony.

First, it is a distinct honor to be nominated and considered for confirmation. I do want to thank Governor Abercrombie and his staff for their collegial and professional work in support of this nomination. Also I want to thank Public Safety Director, Jodie Maesaka-Hirata for her support and that of her staff. Also my heartfelt thanks to my new nominee-colleagues, Bert Matsuoka and Joyce Matsumori-Hoshijo for their warm reception and collegiality.

To answer the Chair's request for a statement addressing four questions:

1. Why do I wish to be a member of the Hawai'i Paroling Authority?

The short answer is I have regarded public service as a lifelong calling and interest. I guess it is embedded somehow in my DNA. After 31 years as a trial judge in Hawai'l and other forms of public service before that (Legal Aid Society of Hawai'i and the United States Peace Corps), this position was one where I felt that my interest, my skill set and this season in my life were congruent. I attach

my CV/resume. I have spent much of my professional life working with "the least, the lost and the left out" and find that with my public school background, life journey, love for Hawai`i's people and culture, coaching for over 40 years, being a father of four, grandfather of four, mentor to law clerks and young people over the years, those opportunities continue to engage me. As a Parole commissioner, it would be a continuation of this service.

2. How do I perceive the role and responsibilities as a member of the Hawai`i Paroling Authority?

First and foremost, these responsibilities are comprehensively and clearly laid out in the Hawaii Revised Statutes, Chapter 353-62. They set forth a daunting set of challenges, one I willingly accept. The responsibilities would also entail following the Department of Public Safety's rules and regulations as well as continuing the hard work and traditions of prior commissioners and staff. I want to emphasize that I regard myself as a "team player" and any transition and changes should be after careful consultation and represent consensus if possible.

3. Why do I believe I might be qualified for the position?

In my view serving as a Family Court Judge, Senior Judge of the Family Court and Circuit Court Judge uniquely qualify me to serve as a Parole Commissioner. To me it is essential to look at each case individually and in light of the reports, social studies, information presented and the interview process and make a reasoned decision that reflects Restorative Justice. To me Restorative Justice blends in community safety, accountability and being receptive to services so an offender can be law abiding, self-sufficient and a contributing member of our community. I attach an article I wrote on that for the Honolulu Advertiser some years ago entitled, "Restorative Justice Makes the Victim Whole Again": (http://www.courts.state.hi.us/images/attachments/RestorativeJustice.gif.) I can also tell you that sitting in judgment of a fellow human being never gets old nor boring and in fact inspiring at what motivated people can achieve! It is a "thin place in life" as my Celtic ancestors might say.

4. What do I hope to accomplish during my term of service?

This is a tall order. I would want to listen, listen, listen to my colleagues, staff, the attorneys, the community groups and national trendsetters about what has worked well, what will work in the future and consult with others in the know. I have already been in contact with Peggy Burke, Principal at the National Parole Resource Center, a group acclaimed nationally and internationally who specialize in helping transition and train new parole boards and vision cast for the future.

Here is their web link. http://nationalparoleresourcecenter.org/. The bottom line there is nothing like hard work, respect for one's colleagues and co-workers and love for the mission. I pledge to bring all that to the table. Having a "growth mindset" and "teachable spirit" should be essential not only for offenders wishing to mend their ways, but those of us who should model and exemplify those qualities who sit in judgment.

Thank you for the opportunity to answer the questions presented. I will be back in Hawai'i on May 2, 2010 and available then to answer further questions at that time. I will be available by email during my absence.
