CHAIR ENGLISH, VICE-CHAIR ESPERO:

Thank you for the opportunity to write in strong support of ERIC MATSUDA to serve on the Commission on Transportation.

I have known Eric, his wife Annette and his family for about fourteen years. I met him in connection with community events on Maui. I later worked with him while I served as Public Works Director for the County of Maui and he was a consulting engineer with one of the local Maui firms. Eric, you should know, is an engineer, but he is also a dedicated family man and community volunteer.

During the past fourteen years, he has impressed me with his common sense and strong Maui island values. He graduated from that fine institution, Maui High School, and is a well-respected licensed engineer. After toiling many years at the Wailuku firm Warren S. Unemori Engineering, he now manages the Maui office of SSFM International, except when he abroad supervising SSFM International's Manila operations.

His work at both WSUE and SSFM provides Eric with experience and knowledge about the engineering design requirements and the funding nuances and entitlement processing for Federally funded transportation infrastructure, the State Transportation Infrastructure Program and prioritizing process, as well as State and County engineering standards. His work has taken him through the entitlement processes of the Federal Highways Administration, the Hawaii Department of Transportation, and the County of Maui Departments of Public Works, Planning, Water and Environmental Management. In short, Eric knows his stuff as an engineer.
