Three qualities that I posses are: integrity, perseverance, and diligence. These qualities would benefit the Land Use Commission as I take kuleana very seriously and have a strong kuleana to my 'ohana to always do the best job I possibly can in whatever I do. I feel I have gained the respect of my peers, business associates, and my community because I am an honest voice that speaks even when my opinion is not the popular one. I am fair and have sacrificed much in my life for the betterment of those around me. I believe in the "it takes a village to raise a child" mana'o, or belief, of my ancestors and have dedicated the past 15 years to lifting up the youth in our community through culture in hopes that they will be stronger leaders if they first know who they are and whom they come from.


