Chair Chang, Vice Chair Har, and Committee Members:

The Hawai'i Community Stewardship Network empowers Hawai'i's communities to care for their environmental heritage. We work with more than 20 communities around the State who are engaged in mālama 'āina activities. Based on dozens of conversations with community members, results of community surveys and interviews, and first-hand experience undertaking collaborative efforts with the Division of Conservation and Resources Enforcement (DOCARE), it is clear that one of the great barriers to effective natural resources management is the fact that DOCARE is not provided the human and financial resources to effectively carry out its considerable mandate.

HB1082 provides a mechanism through which DOCARE can build its own capacity to perform effectively. We are familiar with scenarios in which offers of financial assistance to DOCARE—for example, including as a line item in a grant budget gasoline for enforcement vehicles—were turned down because such a mechanism to transfer the assistance to DOCARE currently does not exist:

We see HB1082 as a win-win solution: The State and the resources reap the benefits.

We support HB1082 and urge you to pass the bill.

Testimony of The Nature Conservancy of Hawai'i Supporting H.B. 1082 Relating to Conservation and Resources Enforcement Special Fund House Committee on Water, Land & Ocean Resources Monday, February 7, 2011, 9:00AM, Room 325

The Nature Conservancy supports H.B. 1082.

Last year, the Conservancy was pleased to provide logistical support, and some financial assistance along with another local foundation, for the Division of Conservation and Resources Enforcement (DOCARE) to begin the process of seeking national law enforcement accreditation from the Commission on Accreditation for Law Enforcement Agencies (CALEA www.calea.org). We believe there are further opportunities for DOCARE to successfully compete for grant funds to complete the rigorous accreditation process, as well as for other projects and programs in support of DOCARE's mission and responsibilities. A dedicated financial account will facilitate these efforts.

The DLNR Division of Conservation and Resources Enforcement (DOCARE) has a specialized mission requiring unique knowledge and training related to the protection of the globally unique and fragile aquatic and terrestrial resources of the State of Hawai'i.

"The overall mission of the Division of Conservation and Resources Enforcement is to promote the safe and responsible use of Hawaii's natural resources."

DOCARE notes as its first objective: "In partnership with others, to help lead the citizens of Hawaii in developing and maintaining a tradition of ethical use, stewardship and sustainability of our land and natural resources."

There is widespread agreement amongst a variety of stakeholders that Hawaii's fragile environment is in need of improved compliance, enforcement and prosecution of violations of our State natural resource laws. A 2006 State Auditor's report concludes that DOCARE officers are spread too thin and lack the equipment they need to do their jobs. In a better economy, the Legislature had been able to support an increase in the number of trained officers and equipment. Not to be deterred by the current tough fiscal climate, DOCARE undertook its own review and strategic planning effort to improve its operational processes. Seeking CALEA accreditation was an important outcome of that process.

Against this backdrop, a number of communities across the state have been organizing themselves to become more directly involved in the care and management of their natural resources, particularly in coastal and near shore areas. Some communities have partnered with DOCARE to raise awareness of natural resource laws and to improve compliance with those laws.

DOCARE needs the continued support and encouragement from the Legislature, the Administration, and the public. It is doing an admirable job of independently seeking non-State resources to keep building its capacity and expertise. H.B. 1082 will give them an important tool to achieve success.

Dear Chair Chang and Members of the House Committee on Water, Land and Ocean Resources:

My name is Pauline Sato. Thank you for the opportunity to submit testimony in support of HB 1082.

This bill establishes a special fund in the Department of Land and Natural Resources for the purpose of setting aside moneys to be used toward the protection of the State's natural resources. Moneys deposited into this fund would come from grants, donations, gifts, fees, related penalties, and appropriations by the legislature, among other sources.

As one who has worked in the conservation field in Hawaii for nearly 30 years and has seen the need for conservation enforcement and education grow while funding resources have shrunk, I wholeheartedly support the establishment of this fund.

There are viable working examples of how a fund like this could be very effective in other states as well as countries. The nation of Palau, for example, has established a fund for marine conservation based on dive fees, generating millions of dollars to support enforcement 24/7 in the popular Rock Islands.

There are likely many ways a fund in Hawaii could become financially sustainable if properly managed. With such a designated fund that carries over excess moneys from year to year, the fear of having moneys disappear into the "black hole" (aka the state's general fund) would be alleviated.

This bill needs to become law today. I humbly ask you to support the passage of HB 1082. Thank you for the opportunity to testify on this measure.
