RE: H.B. 108; RELATING TO CRUELTY TO ANIMALS.

Chair Keith-Agaran, Vice-Chair Rhoads, and members of the House Committee on Judiciary, the Department of the Prosecuting Attorney of the City and County of Honolulu submits the following testimony, supporting the intent of House Bill 108.

The purpose of House Bill 108 is to amend Chapter 711, Hawaii Revised Statutes, to create separate offenses for 'dogfighting' in the first and second degrees. With these amendments, dogfighting in the second degree would include those who knowingly wager on or attend a dogfight, within specific definitions of the term "attend," and dogfighting in the first degree would encompass those involved in putting on a dogfight and/or handling the dogs.

The Department of the Prosecuting Attorney supports this bill's intent of decreasing or eliminating dogfighting, which is a cruel and unacceptable activity, and further agrees with the intent to address "demand" as well as "supply" for the industry. Nevertheless, the Department also recognizes that these amendments may be potentially difficult to enforce.

Based on the foregoing, the Department of the Prosecuting Attorney of the City and County of Honolulu supports the intent of House Bill 108. Thank you for the opportunity to testify on this matter.



SUBJECT: Support House Bill 108 relating to cruelty to animals

Dear Chair Keith-Agaran, Vice Chair Rhoads and Members of the Committee on Judiciary:

We believe that Hawaii's laws that prohibit animal fighting and cruelty will be strengthened by your support of HB 108 to specifically address dog fighting as a blood sport and those who attend them.

Hawaii ranks last in terms of having the nation's weakest dog-fighting laws and we do believe that it is being practiced here in our islands. Deputized by HPD to enforce state and county animal cruelty laws, we have received reports of dog fights after they have taken place, solicitation of bets, bait dogs that have been killed and found, as well as underground websites that promote local dog fighting.

This bill before the Judiciary Committee would effectively prohibit the use of dogfighting equipment, betting, use of bait dogs, and attending a dog fight – all of which would help the Humane Society and law enforcement partners statewide in their efforts to pursue such cases and investigations.

Forty percent of Oahu's households have dogs. Dogs are companions and not tools for cruelty and profit.

We ask for your unwavering support, which would stand as a strong message to dog fighters that we are aware that this inhumane blood sport does exist in our islands and dog fighters and all participants should be prosecuted to the fullest extent of the law.

Your support of HB 108 will help strengthen Hawaii's animal protection laws. Thank you for the opportunity to provide testimony in Support of HB 108.

Dear Honorable Chair Keith-Agaran, Vice-Chair Rhoades and Committee Members:

On behalf of our more than 49,000 members and supporters of The Humane Society of the United States in Hawaii, I would like to thank you for this opportunity to speak in strong support of HB 108; relating to dogfighting. We thank Rep. McKelvey for his introduction of this critical crime and cruelty prevention measure, and Senator Hee for introducing the Senate companion bill (SB 1069).

In a recent national ranking of dogfighting laws in the states and the District of Columbia, Hawaii ranked 50th, in part because our law provides no penalties for those attending or wagering on an organized dogfight. This bill would also add critical language relating to those who possess, breed, raise, sell or transport dogs for fighting purposes, including explicitly prohibiting the use of stray or stolen pets as "bait" to train fighting dogs. Under our current law, dogfighters could claim they only breed or sell fighting dogs and not be subject to any charges. Dogfighters could also claim they don't legally "own" the dog which can be difficult to establish.

The 2007 Michael Vick case sadly exposed that no community is immune from dogfighting—a community that also believed that such activity was not occurring. In fact, it was strong anti-dogfighting laws, such as the proposed, that allowed Vick and his co-conspirators to be successfully charged and convicted. Our organization has assisted in hundreds of animal fighting raids across the country and we are sadly aware that dogfighting activity has been present in Hawaii for many years.

Need for "knowing attendance" penalty

Under our existing law, one would need to be literally caught in the act of dogfighting, which, due to the clandestine nature of such activity, is extremely rare. Even if law enforcement were to encounter a dogfight in progress, under current law, those attending as knowing participants would face no legal penalty. Attendees provide much of the profit associated with dogfighting. The money generated by admission fees and gambling helps keep this "sport" alive. Because dogfights are illegal and therefore not widely publicized, attendees do not merely happen upon a fight; they seek it out. They are willing participants who support a criminal activity through their paid admission, wagering and attendance.

Public Safety Issue:

Dogs used for fighting have been bred for many generations to be dangerously aggressive toward other animals. The presence of these dogs in a community increases the risk of attacks not only on other animals but also on people. Children are especially at risk, because their small size may cause a fighting dog to perceive a child as another animal.

Associated Crimes:

Dogfighting is also associated with other crimes such as illegal gambling, drug distribution and human violence. According to a study conducted by the Chicago Police Department, of more than 300 people arrested for crimes against animals (including dogfighting), more than 65 percent had also been arrested for battery-related violent crimes and 70 percent for illegal drugs.

Cruelty to dogs and "bait" animals

The injuries inflicted and sustained by dogs participating in dogfights are frequently severe, even fatal. Dogs used in these "events" often die of blood loss, shock, dehydration, exhaustion, or infection hours or even days after the fight. Other animals are often sacrificed as well. Some owners train their dogs for fights using smaller animals such as cats, rabbits or small dogs. These "bait" animals are often stolen or stray pets or animals obtained through "free to good home" advertisements.

This critical measure would bring Hawaii's law in line with the rest of the country and provide law enforcement with more comprehensive laws to investigate and charge those involved with illegal dogfighting. Furthermore, upgrading our law serves as a deterrent for those who may consider becoming involved in illegal dogfighting activity and sends a clear message to the community that dogfighting is a cruel and serious crime that will not be tolerated.

We respectfully urge your passage of HB 108 to reduce crime, cruelty and create safer communities for pets and people alike.

The Oahu Society for the Prevention of Cruelty to Animals was founded in April of 2009. Our first day of operations was marked by the largest rescue in the history of Hawaii. Amongst the 132 dogs rescued there were 5 pit bull terriers that were quarantined and un adoptable due to behavioral issues. Most likely they had been chained their entire lives to protect or pursue the ventures of their owners. In our first year of operation, a large percentage of our rescued dogs are pit bull terriers. Many of which have been altered for fighting.

Pitt bull terriers bred and raised for fighting routinely have their ears and tails cropped. If they are used for training, the trainers will file their teeth down so not to inflict injury on the superior dog or opponent. The Oahu SPCA rescues pitt bull terriers with cropped ears that have been further mutilated so that only a small stump remains. The initial cropping is done without anesthesia and the further damage results in repeated brutal attacks and excruciating pain. The average dog has the mental capacity of a five year old child. Their threshold to pain is exactly the same as an adult human. Subjecting a five year old to defend it life on a daily basis is illegal.

The presence of dog and chicken fighting is also indicative of a number of other illegal activities. Addressing the issue of dogs chained to police the perimeters of a property can also be associated to crimes against humans. Statistics show that dog fighting is directly associated to violence against children and women. There is also an overwhelming correlation with dog fighting which raise revenues and drug trafficking. Illuminating dog fighting reduces the crimes directly associated with children and humans as well. Canines that are trained for dog fighting have spent their lives defending their own lives. As result they display aggression to humans as well who have trained them. Please stand behind House Bill 108. We must be diligent and watchful of all people and animals that live on our islands.

The recent pro-bowl that brought Michael Vick to Hawaii also renewed the awareness of dog fighting issues locally. Dog fighting is a major social problem that is associated with unethical and criminal behavoir. Despite some claims that Hawaii is not affected by dogfighting, it is in fact present and nearly unpreventable with the limited dog fighting laws currently in place.

As a volunteer for the Oahu SPCA (Society for Prevention of Cruelty to Animals), an animal shelter in Kapolei, I encountered many rescued dogs, but one stands out in my memory. Tennyson is a bulldog mix with a sweet face and an even sweeter disposition. Unfortunately, his gentle kindness was also his vulnerability. When he was brought to the shelter as a rescue, his skin was peppered with scars, his ears were jagged and torn and his muzzle was carved with bite marks. Tennyson's affinity to licking volunteers' hands revealed teeth that had been filed down nearly to the gum line. The roots of his teeth were painfully exposed.

At first, he appeared to be the victim of mutilation, but upon closer interaction with Tennyson, we realized the likely source of these scars. Tennyson's mysterious past became clear; he was a bait dog. Baiting is an extremely cruel

practice testing an animal's "fight instinct" on a dog with intentionally limited abilities to retaliate (clipped nails, filed teeth or taped-shut muzzle). Bait dogs are often mauled, like Tennyson, or killed in the process. Wherever dog fighting exists, baiting is surely to follow. And with local evidence of bait dogs, we can assert that dog fighting is present in Hawaii.

Dog fighting and the criminal activities associated with it: animal cruelty, gambling, drug related offenses, violence and gang activity, make this a priority issue for Hawaii – a state with the weakest dog fighting laws in the United States.

Please consider Tennyson when you vote on HB108 and help prevent other dogs from suffering the cruelties of dog fighting.
