TESTIMONY ON H.B. No. 112 - RELATING TO CABLE TELEVISION SYSTEMS

TO THE HONORABLE ROBERT N. HERKES, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Everett Kaneshige and I am the Deputy Director of the Department of Commerce and Consumer Affairs (the "Department") and am testifying in support of HB No. 112.

The Department recognizes the importance of PEG access to democracy and the exchange of ideas and the opportunity for the public to share their ideas, using a media that would be otherwise cost-prohibitive for most people.

Therefore, the Department supports an exemption from HRS chapter 103 for the designation of access organizations for public, educational, and governmental (PEG) access channels as described in lines 4-10 on page 1 of the bill. The Department's position is consistent with its previous requests to the State Procurement Office in 2005 and 2006 for a similar exemption and also the recommendations of the H.C.R. 358 Task Force Report to the 25th Legislature on December 16, 2008.

The remainder of the bill addresses the procedure to be used by the Department in conjunction with designation of the PEG access organizations. The Department points out that these procedures are already contained in section 16-131-70 of the

Hawaii Administrative Rules and therefore it is not necessary to add similar provisions to HRS chapter 440G.

Furthermore, in the event this bill is enacted, HAR section 16-131-70 will need to be revised to delete the current language which requires the Department to comply with HRS chapter 103. Revisions to this section would require public hearings and will provide the Department with the opportunity to work with the PEG access organizations and our shared public, educational and governmental constituents, to develop rules which could address not only the designation of organizations but also specific terms and conditions of the agreements between the Department and the PEG access organizations.

Thank you for the opportunity to testify on H.B. No. 112. I will be happy to answer any questions that members of the Committee may have.

Chair Herkes, Vice-Chair Yamane, and committee members, thank you for the opportunity to testify on HB 112.

The State Procurement Office (SPO) opposes the amendment in SECTION 1 which proposes to exempt from HRS chapter 103D the designation of access organization for public, educational, or governmental access channels.

A solicitation was issued on May 20, 2010 by SPO on behalf of the department of Commerce and Consumer Affairs (DCCA), Cable Television Division, and is currently proceeding through the request for proposal (RFP) process. RFP-10-007-SW is for the services to Operate, Maintain, and Manage Public, Educational, and Governmental (PEG) Access Channels, Funds, Facilities, and Equipment, and generally contains the items listed in the proposed bill for the director to consider such as the public need for the proposed services, qualifications and financial responsibility of the applicant, etc. The solicitation and amendments can be viewed at: http://hawaii.gov/spo/hawaii-public-procurement-code-chapter-103d-hrs/solicitations/peg/public-educational-and-governmental-peg-access-channels-funds-facilities-and-equipment-rfp/.

Public procurement's primary objective is to give everyone equal opportunity to compete for Government contracts; to prevent favoritism, collusion or fraud in awarding of contracts. The true nature of competition gives government agencies the benefits of knowing that the acquiring of goods and services were conducted in a fair and objective manner. Meeting this objective requires a single set of statutes and rules that define and mandate the use of selection processes that are competitive, efficient, fair, transparent, open and impartial.

Statutory exemptions for specific agencies are contrary to the Hawaii Public Procurement Code, section 103D-102, HRS, on the applicability of the chapter that states in part "... shall apply to all procurement contracts made by governmental bodies whether the consideration for the contract is cash, revenues, realizations, receipts, or earnings, ..." Any governmental agency with the authority to expend funds should be in compliance with chapter 103D, which promotes the policy of fair and equitable treatment of all persons who deal with the procurement system; fosters effective broad-based competition and increases public confidence in public procurement.

The SPO opposes statutorily exempting specific agencies from the Code, as it is not in the best interest of government, the business community, and the general public. The Code establishes a time-tested, fair, and reliable process for award of contracts. The competitive procurement processes of the Code are to insure that all potential providers are afforded the opportunity to compete for the required services. To the extent agencies may need specific purchases to be exempted from Code requirements, the Code provides an exemption process on a case by case basis as opposed to a total blanket statutory exemption.

The Code should not be viewed as an obstacle to a purchasing agency's mission, but rather as the single source of public procurement policy to be applied equally and uniformly. It was the legislature's intent for the Code to be a single source of public procurement policy. If individual agencies are exempted and allowed to develop their own individual processes, it becomes problematic and confusing to vendors, contractors and service providers that must comply with a variety of different processes and standards. Fairness, open competition, a level playing field, and government disclosure and transparency in the procurement and contracting process are vital to good government. For this to be accomplished, we must participate in the process with one set of statutes and rules. To legislate that any one entity should be exempt from compliance with the procurement code conveys a sense of disproportionate equality in the law's application.

If the Legislature intends to exempt specific programs or funds from the Code, the exemption should include assurances that the agency's exempt process includes fair and open competition, disclosure, transparency, due process for aggrieved parties, a defined selection and awards process, and the various elements contained in the Code to ensure public confidence that the exempt procurement process is as fair as the Code.

There is no compelling reason to exempt the procurement of contracts to manage and operate PEG access channels, funds, facilities and equipment from fair and open competition. We request that SECTION 1 be deleted. Thank you.

Subject: Letter in Strong Support of HB 112 Relating to Cable Television Systems

My name is Roy Amemiya, Chief Operating Officer and Interim President/CEO of 'Ōlelo Community Television, the PEG Access Provider for Oahu. I am writing to strongly support HB 112 Relating to Cable Television Systems. This bill would change the State's procurement process of PEG Access service providers by designating a new process within HRS 440G that is modeled after the process used to procure cable franchises.

The genesis of this measure actually began in 2008 with the unanimous House and Senate enactment of HCR 358, HD1 which established a task force to "solicit public input and examine methods other than public procurement code process to oversee PEG organization expenditures and ensure proper checks and balances". The resolution text is also clear that this body felt that procuring PEG access using HRS 103D has many shortcomings and that another method should be explored by the task force.

Members of the 12 person task force consisted of representatives from the DOE, the UH, the cable advisory committee, all four county governments, all four PEGs, and the state cable administrator. I served on the task force and was an 'Ōlelo board member at the time.

The task force met a total of 7 times and debated multiple procurement options. These meetings were open to the public and testimony was received from members of the community at each meeting. In the end, all task force members agreed on the option that is recommended in the HCR 358 Task Force Report to the 25th Legislature and is proposed in this bill. Briefly described, the concept is to take the existing process for both new and renewing cable franchise applicants and apply a similar process to PEG access providers. That process, among other things, requires that a public hearing be conducted on the application. In that way, it is much more transparent than the current RFP process. It also allows the DCCA to get an understanding of the needs of the community. This, I believe would be very beneficial in crafting concrete contract

terms and conditions, as well as performance measures – something that is very elusive in the current RFP process.

Adoption of this bill will eliminate the challenges that the House and Senate identified when it passed the aforementioned concurrent resolution and replace it with an existing and proven process that was unanimously agreed to by a diverse group of stakeholders. Accordingly, I ask that you support this measure by moving it out of committee.

Thank you for the opportunity to testify. I am pleased to answer any questions that you may have.

My name is Gene Zarro, I am a 35 year resident of Maui and have enjoyed and looked forward to the programming of Akaku since its inception.

I am testifying in strong support of HB 112.

I am honored to say I am the Chairman of the Board of Akaku an organization whose goal is to not only empower the voice of Maui's citizens and their right of Free Speech through Public Access TV but also to allow the creative side of Mauians to have another outlet for all that wish to enjoy.

Akaku is a well run 501c3 organization with a board of 13 members representing the Community, the DOE, UH Maui, Maui County Government and the Producers.

It is an organization that is audited yearly by an outside CPA firm and passes these audits with little comment.

The bill is intended to provide strong accountability and performance standards for Akaku, Maui County's Akaku Community Television, as well as the community-based public access television providers serving Oahu (Olelo Community Television) the Big Island (Na Leo O Hawaii) and Kauai (Hoike Community Television) These community-anchor, non-profit, public access organizations have been a vibrant part of our public discourse and civic engagement throughout the state for more than twenty years and this bill will ensure that they continue to be fully accountable and responsive to the needs of our local communities, the DCCA and the state.

The content of this bill incorporates draft rules from your own 2008 HCR 358 Legislative Task Force which recommended that this reasonable method of PEG Access designation be used in lieu of a

fatally flawed state procurement process initiated six years ago by the previous Administration, an ongoing RFP process that has cost the PEG Access organizations and the state many thousands of dollars with no end in sight.

Recommendation 3 of the HCR 358 Task Force Report states:

"The Task Force recommends that in place of competitive procurement, the DCCA be charged with adopting Administrative Rules that guide a new process for the designation of a PEG Access organizations in a manner that is similar to the process used by DCCA for cable franchises, a process that is already well understood by the DCCA and the public, This process should provide ample opportunity for input by the public on each island within the local franchise area and allow for interested parties to intervene

HB 112 provides for a regulatory framework that will silence even the harshest critic of the current PEG access designation. We would like to respectfully request that your committee approve HB112 which will grant Akaku and the other community media organizations a sense of certainty they have earned from decades of dedicated community service. This will allow these community-based organizations to continue to expand and build upon their only mission: to provide extended media opportunity and a vibrant voice for all the people of Hawaii Nei.



Aloha Chair Herkes, Vice Chair Yamane and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative working on prison reform and justice issues in Hawai'i for more than a decade. We respectfully offer our testimony always being mindful that Hawai'i has some 6,000 people behind bars with almost 1,800 individuals serving their sentences abroad, thousands of miles away from their loved ones and homes – ancestral home for a disproportionate number.

I am also the producer and host of *Hawai'i InJustice*, an 'Olelo community television show that airs the first Tuesday of every month at 8:30 pm and every Thursday morning at 8 am on Channel 54.

HB 112 allows the Director of Commerce and Consumer Affairs (DCCA) to designate an access organization to oversee public, educational and governmental channels on cable television.

Community Alliance on Prisons stands in strong support of this measure that preserves the community voice and clarifies Chapter 440G, outlining the criteria the Director must consider before letting a contract from PEG access.

This is important because the community voice is part of the Director's criteria for selection. This is especially vital in challenging economic times. We the people must always be vigilant that the government doesn't corporatize public assets. These are known as The Commons.

PEG (Public, Education, Government) access is a vital part of a thriving democracy. It provides access to information that is, in some cases available nowhere else. Access to current information is even more important for Hawai`i. Access to technology facilitating information to connect our islands is not a luxury – it is a necessity.

This bill ensures that the public has a voice in keeping public access, well, public! Public access (and we mean PEG access) is

- a public right
- democracy in action
- a way to create a more informed citizenry
- · a way to build strong, involved, and committed communities
- a window for policymakers to see, hear and understand issues important to their constituents

When we say public access is a public right, we mean that is the rent - and it is indeed low rent considering the corporate benefit cable television operators gain from the use of public-rights-of-way.

In election cycles, the community can tune in and hear from candidates running for office. This creates a more engaged and educated voter.

Keep Public Access PUBLIC! We support this measure that ensures the public will have a voice in the PEG process that is made clearer with the amendment to Chapter 440G.

A vibrant democracy demands an involved citizenry and every effort to educate and involve the citizens on important issues should be wholeheartedly supported by our government.

Preserving, enhancing, and amplifying the public, educational, and governmental voices is what We the Reople is all about!

My name is Lance D. Collins. I am an attorney in private practice on the island of Maui and testify on my own behalf. I <u>support</u> this bill.

I helped draft the language in this bill which was originally offered in Senate Bill 1789 during the Twenty Fourth Legislature of the State of Hawai'i then, in similar form as Senate Bill 2387 during the Twenty Fifth Legislature of the State of Hawai'i.

This bill helps resolve some of the consequences of the unusual policy decisions made in the last five years by the Department of Commerce and Consumer Affairs regarding cable access and access organizations.

The bill does not address the dearth of appropriate regulatory oversight of cable access and leaves too much of the important public policy decision-making regarding cable access to state educational departments, incumbent access organizations and the county governments.

For example, the important policy considerations related to the diversion of franchise fees to the University of Hawai'i and the Department of Education should not be left to the outcome of the unequal bargaining between those state departments and the incumbent access organizations.

Nevertheless, the bill creates a level of stability and clear procedure for the director to exercise her discretion in designating access organizations and may help resolve some of these other issues.
