I am urging your support passage of HB121, HD1, Appropriations for Civil Air Patrol(CAP), which is going to be decided on Friday, April 1, 2011, at 9:00A.M. in Conference Rooom 211. During the Chilean earthquake on 27 February 2010

and again during the recent Japan earthquake and tsunami which struck and damaged parts of the Hawaiian Islands, Civil Air Patrol

responded and provided shoreline aerial warning to campers, swimmers, and to residents of areas without the benefit of state sirens and public address systems. On March 27, 2011, upon the initial call from the Hawaii State Civil Defense Center, CAP activated Air Operations

Centers on Kauai, Oahu, Maui and on the Big Island of Hawaii. Five hours prior to the impact of the tsunami, CAP had launched

eight (8) single engine airplanes to pre-determined tsunami routes to provide warning. Fifteen (15) Kauai CAP members responded to Lihue Airport and was ready to fly the three (3) Lihue based CAP aircraft within one (1) hour of notification. At the request of the Kauai Civil Defense Agency, the Kauai based CAP aircraft began activating airborne sirens at 10:18pm along the shorelines of Kauai and Niihau Islands. This recent tsunami required our aircrews to fly in pitch black night which we receive minimal training. But because of the impending danger to the citizens of Hawaii, CAP volunteer aircrews launched. **Truly "service before self!"** Following the tsunami, CAP was tasked by State Civil Defense to fly "damage assessment" flights. CAP aircrews were the first to note the "floating house" in Keahou, Hawaii. CAP is in dire need of funding to train and sustain this state mission. I urge your support to pass HB121, HD1, Appropriations to Civil Air Patrol to continue this critical emergency need for our state of Hawaii
