COMMITTEE ON FINANCE

The Department of Transportation (DOT) supports with reservations H.B. 1239 which would establish a Hawaii state ferry system and the Hawaii state ferry system special fund for the operation of a system to ferry people and cargo between the islands.

The DOT regularly evaluates new forms of intermodal transportation in an effort toward providing Hawaii's citizens and visitors with access to safe and dependable transportation routes that help to stimulate our economy and improve quality of life. In that spirit, the DOT supports a statewide ferry transportation system.

However, the DOT's primary mission and statutory responsibility is to plan, design and construct transportation infrastructure. The DOT does not have the resources or expertise to operate a ferry business. Doing so will only dilute the Department's resources from executing its primary mission. The DOT does support instead, however, another private entity or public-private partnership to operate a ferry business, so long as it is done in full compliance with all applicable laws, rules and regulations.

In closing, the DOT supports the establishment of an interisland ferry system, but recommends that it be operated and maintained by an entity other than the DOT.

RELATING TO FERRIES

House Bill No. 1239 establishes a Hawaii State Ferry System Authority and creates a Hawaii State Ferry System special fund to be administered by the Department of Transportation. The special fund will receive moneys from rates, fares, and charges received from the operation of a statewide ferry system to be used to fund the operations of the ferry system.

As a matter of general policy, the Department of Budget and Finance does not support the creation of any special fund or revolving fund that does not meet the requirements of Sections 37-52.3 and 37-52.4, Hawaii Revised Statutes. Special and revolving funds should: 1) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries of the program; 2) provide an appropriate means of financing for the program or activity; and 3) demonstrate the capacity to be financially self-sustaining. In regards to House Bill No. 1239, it is difficult to determine whether the Hawaii State Ferry System special fund would be financially self-sustaining.
