HOUSE BILL NO. 12 RELATING TO PLANT THEFT

Chairperson Tsuji and Members of the Committee:

Thank you for this opportunity to provide testimony on HB 12 relating to plant theft. The bill seeks to require a person sentenced for an offense involving theft of an agricultural product or commodity, make payment to the property owner for the value of the stolen agricultural product or commodity and the cost of replanting the agricultural product or commodity. The Department strongly supports this bill and respectfully requests to include the addition of repayment for damages caused by vandalism.

The value of agricultural theft and vandalism losses totaled millions of dollars. For example, the recent vandalism of papaya fields on Oahu and the Big Island resulted in substantial financial losses to the farmers on current and future production. Income that would have been earned by the vandalized trees will not be available to sustain the current operation as the fields must be replanted. This action could conceivably displace the production of locally grown papayas.

Chairman Tsuji, Vice Chair Hashem and Members of the Committee:

My name is Alan Gottlieb, and I am a rancher and the Government Affairs Chair for the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC) is the Statewide umbrella organization comprised of the five county level Cattlemen's Associations. Our 130+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council <u>supports</u> HB 12, <u>with a suggested change</u> to add livestock to the definition of "agricultural product or Commodity: on lines 14-18 of page 1.

Livestock Theft is a huge concern to cattle ranchers and other livestock producers across the state.

Property damage, to livestock, damaged fences, stealing of agriculture products can be irreversible for the landowner or operator. Thousands of dollars are spent per year in repairing damages created by trespassers and it affects the economic survival for all ag commodities. We are often easy targets because of our remote locations, easy access and limited surveillance. We have a responsibility to be good stewards of our land and trespassers make it difficult to continue that without proper consequences.

In closing, agricultural product theft, including livestock, can ultimately create intense damage to our agricultural economy and this needs to be prevented by stricter laws and stiffer fines. We need to increase advocacy for farmers and ranchers who want to continue to produce food in an efficient, profitable, and responsible manner. Government needs to protect the intrinsic value of ranchers and farmers for the present and the future, by making greater efforts to limit liability of all agricultural landowners and HB 12 will help create that.

My name is Daniel Nellis and I am the Operations Director for Dole Food Company Hawaii. Dole grows pineapple, coffee, and cacao on our Oahu farm and also leases land to independent growers producing a variety of diversified crops and livestock.

Dole Food Company Hawaii strongly supports HB 12 and supports the recommended change proposed in the testimony of the Hawaii Cattlemen's Council that livestock be added to the definition of "agricultural product or Commodity" on lines 14-18;page 1.

Theft of agricultural products hurts the farmer and rancher directly but also potentially harms the public that later consumes stolen products that have not gone through the rigorous inspection before sale, that Hawaii's conscientious producers routinely perform. Food security, food safety, and affordable locally produced food all depend on the producer being able to make a fair living. Theft always adds cost to the final product and that cost should be paid by the perpetrator instead of the producer and consumers.

I appreciate Cynthia Thielen introducing this Bill on the citizens of Kailua's behalf and the Committee meeting and hearing the facts behind it. Having grown up here, I love my home and the people here and know that passing this Bill is the right thing to do.

To Whom It May Concern:

In speaking to Chairman Tsuji a week and ½ ago he stated that there are already bills on the books that protect the investment that Hawaiian citizens make in their landscaping. I would like to tell you what our experience has been in this matter:

Twelve years ago we bought a house on Kuuhale Street, having previously lived on Kuukama Street for 10 years. Since we purchased our home in 1998, we have had people entering our yard stealing our plants. We've spent thousands of dollars on trees and plants, landscapers, fertilizers, and all that was needed to maintain and beautify our property. Over the 12 years, we've had pikake, pakalana, jade plant, 50 orchid plant(s), 15 roses, hibiscus, while, yellow, blue, red ginger, and numerous others stolen. We've installed motion sensor lights, cameras, 2 deadbolt locked gates, solar lights and many other security devices per HPD's directive to do so. We've reported these crimes to the Police, written complaints, and done everything we've been advised to do to stop this ongoing crime. To date, not only does the theft continue, but now, our 50 foot palms that line our backyard are being destroyed-fronds and heads of trees cut off. This bill will ensure that when the thieves are caught and prosecuted we can recoup our investment and once again restore our yard(s). The damage is now in the \$100,000 range.

What this bill does not do is restore the sleepless nights, worry, and general depression from having strangers come uniformly into our yard both night and day, whether we're home or not, and help themselves to anything they want. But if this bill is passed it will go a long way toward renewing our belief in the people of Kailua and people in general. Please, please pass this bill. Thankyou.

Dear Chairman Clift Tsuji: I'm writing in support of HB 12, introduced by Representative Thielen. This bill will go a long way toward preventing plant theft.

I'm a member of the Board of Directors at Meridian East Condominium in Kailua. In the Spring of 2010, our Association voted to implement a major landscape upgrade. During the planning process, we became aware of the plant theft issue on the Windward Side. Meetings with neighboring businesses, our Landscape Contractor and other organizations resulted in extensive publicity. We feel the exposure deterred thievery and firmly believe this bill which carries substantial penalties will be an even greater deterrent.

Our experience here at the Meridian East was we had to add \$2984.00 to erect an 8-foot fence for a period of 6-months to protect our substantial investment in the new landscape. This is outrageous!

Passing the H.B.NO.12 injures no one, except the plant thieves. Thank you, Thomas Roberts
