Chairs Dela Cruz and Ige, Vice Chairs Solomon and Kidani, and Members of the Senate Committees on Water, Land, and Housing and Ways and Means.

The Office of Planning (OP) does not support HB 1405, HD 1, because OP does not have the staff and fiscal resources to implement planning for a statewide greenways system, the initiative is not incorporated in the Executive Biennium Budget, and the bill's smart growth concerns are already covered under current State planning and land use laws.

OP is a proponent of smart growth principles, and we believe that a coordinated, statewide greenways system is one element in achieving smart growth. Unfortunately, OP cannot undertake new tasks at this time due to resource constraints and existing priorities.

However, please be aware that OP incorporates smart growth principles into its planning, land use, and Coastal Zone Management programs and activities to the extent that it is consistent with existing law, and to the extent that resources are available to provide technical assistance in the achievement of smart growth principles. Chapter 226, *Hawaii State Planning Act*, Hawai'i Revised Statutes (HRS), contains many policies and guidelines for smart growth, similar to those

enumerated in the bill, and requires as well that decision-makers consider these principles with regard to all major State and County activities, including:

- Ensuring that more affordable housing is made available to very low-, low- and moderate-income segments of Hawai'i's population;
- Fostering a variety of lifestyles traditional to Hawai'i through the design and maintenance of neighborhoods that reflect the culture and values of the community;
- Pursuing an openness and responsiveness in government that permits the flow of public information, interaction, and response;
- Promoting integrated multi-modal transportation system that services statewide needs and promotes the efficient, economical, safe, and convenient movement of people and good;
- Facilitating the use of available vacant, developable, and underutilized urban lands for housing;
- Identifying, conserving, and protecting agricultural and aquacultural lands of importance and initiating programs to promote economically productive agricultural and aquacultural uses of such lands;
- Encouraging urban growth primarily to existing urban areas where adequate
 public facilities are already available or can be provided with reasonable public
 expenditures, and away from areas where other important benefits are present,
 such as protection of important agricultural land or preservation of lifestyles;
- Promoting the preservation and restoration of significant natural and historic resources; and
- Encouraging design and construction practices that enhance the physical qualities of Hawai'i's communities.

OP, as required by HRS §226-53 in administering the Hawai'i State Planning Act, will continue to incorporate these principles in the performance of its current duties, and will strive to provide technical assistance to implement the smart growth principles embodied in Chapter 226, HRS, as resources permit.

The Department of Planning and Permitting (DPP) **supports** House Bill No. 1405, HD1, which would promote smart growth and sustainability in the state by requiring the Office of Planning to develop and establish a statewide system of greenways and trails. Greenways and trails are a key strategy for encouraging more active and healthy lifestyles, as well as more economical and environmentally-friendly means of transportation.

The legislation specifically calls for the creation of a system plan for statewide greenways and trails. Such a plan would provide enhanced predictability for local communities and the community planning process and would allow for more systematic planning, design and funding of greenway and trail projects. HB331 Proposed SD2 RELATING TO PUBLIC LANDS

The Office of Hawaiian Affairs offers the following comments on HB331 Proposed SD 2.

Among other things, HB331 Proposed SD2 would allow the Department of Land and Natural Resources (DLNR) to extend lease terms for intensive agricultural, aquaculture, commercial, mariculture, special livestock, pasture, or industrial leases for a total of 65 years.

The bulk of the land managed by DLNR is former government and crown land that was ceded by the Republic of Hawai'i to the United States in 1898, "without the consent of or compensation to the Native Hawaiian people of Hawaii or their sovereign government[.]" P.L. 103-150 (1993). Sixty-five year leases that exceed the length of a generation ties the hands of the community and future generations of land and resource managers and unduly restricts their ability to make sound decisions. Moreover, long-term leases often lead to a sense of entitlement on the part of the lessee that can and has resulted in alienation of leased land in Hawai'i.

HB331 Proposed SD2 would also create a "public lands development corporation" within DLNR to develop state lands.

The Admission Act section 5(f) created the public land trust pursuant to which certain land and the proceeds or income from the disposition of that land are to be held by the State of Hawai'i for five public purposes, including the betterment of the conditions of native Hawaiians. Accordingly, all state agencies, including DLNR and the proposed public lands development corporation, must serve as a trustee and carry out fiduciary responsibilities in their management of public trust land. These duties include, among other things, acting in the best interest of the beneficiaries, taking reasonable care, acting as a prudent person would in similar circumstances, and performing due diligence.

Hawai'i Admission Act section 5(f), Hawai'i Constitution, article XII, Haw. Rev. Stat. chapter 10, Act 178, SLH (2006), and Executive Order 06-06 impose on

the state further trust obligations with respect to public trust lands, including accurately determining and accounting for all income and proceeds from the use of lands within the public land trust, and transferring to OHA all payments due. OHA requests that this bill be amended to explicitly state that all revenue generated from the use of public trust land under control of the public lands development corporation will be subject to Act 178, SLH 2006.

Aloha Chair Dela Cruz, Chair Ige, and Members of the Committees:

The Hawai'i Chapter of the Sierra Club, with 8,000 dues-paying members and supporters, supports HB 1405, HD1. This measure would require the Office of Planning to establish a statewide system of greenways and trails.

Hawai'i offers some of the most stunning hiking trails and beaches in the world, attracting residents and visitors alike for their beauty and challenge. Access to Hawaii's coast and mountain areas for recreational, cultural, or subsistence uses is a core value that residents have respected for generations. While we often take for granted our ability to enjoy and hike on our public land, we need to ensure that these historical trails are protected and connected together to offer maximum use. In addition, long-term planning helps ensure measures are put into place to encourage access to private property for recreational use such as hiking and camping.

Hawai'i's trails and greenway systems are already of an incredible value. The Sierra Club currently leads hundreds of hikes each year, with thousands of high school students, residents, and tourists participating each year, with a strong preference to highlighting the cultural and environmental background of Hawai'i. These programs are incredibly popular and help tie Hawai'i's youth to our 'aina and the history of our islands.

While the Sierra Club supports the passage of the bill in its present form, we respectfully suggest it might be broadened to look include an examination of other elements of smart growth, including an analysis of the long-term land use planning needed to support Hawai'i's energy and food needs. If there is a willingness to move in this direction, we are happy to provide proposed amendments.

Thank you for the opportunity to testify in opposition to HB 1405 HD 1 which calls for the Office of Planning to develop a plan to establish a statewide system for greenways and trails and to offer comments. We cannot support this measure at this time for the following reasons:

- 1. There is a State Master Plan for pedestrians in process now through the Dept. of Transportation;
- 2. The Department of Land and Natural Resources, through its Division of Forestry and Wildlife (DOFAW) already has implemented and works with a statewide system for trails called Na Ala Hele the Hawaii Trails and Access System as well as working with the Historic Trail Protection & Development program;
- 3. There is a bill making its way through the legislature, SB 1529, HD 2 that is calling for a task force to review and update the Hawaii State Plan with oversight by the Office of Planning. The Hawaii State Plan incorporates the physical environment scenic, natural beauty and historic resources;
- 4. The Counties already address the issue of smart growth and open greenways through county community development plans.

Given the fiscal state of Hawai'i, it would be more prudent to examine the existing programs that are now within the state government system to either consolidate these programs, or to examine whether or not they are duplications and should not be implemented.
