Weed and Seed goals is to provide assistance to our kupunas by educating them to secure their homes, pedestrian safety, identification fraud and providing resources such as food distributions held at our safe haven in the community. There is a need to go beyond this and we need laws that will protect them.

I wholeheartedly support this bill. I am a retired social worker and worked with seniors on the Waianae Coast. I can attest to having clients whose family members took advantage of their parents financially. I dealt with 2 very heart wrenching casess of Elder Abuse. One woman lost her home soon after her husband died. Her two children came home from the mainland and took over the power of attorney. Then, without her knowledge, her children changed her name on the deed of her home, to their names and later kicked her out of her own home. The other case required me elicit the assistance of Elder Abuse. A police officer subsequently accompanied me to the home of my client. We had to forcefully ask the son to leave the home because, he had been physically abusing his dad for money. We desperately need laws to protect our seniors who are very vulnerable to being taken advantage of. Please pass this bill in behalf our our kupunas welfare.

Most of these incidents involve caretakers who manipulate their way into defenseless seniors' financial accounts (sometimes use of force involved). I had also witnessed an elderly woman being " roughed up" by her son on regular basis, as he drained the poor woman's bank account. I did contact HPD to report, but no action taken w/ elderly woman not willing to talk (for fear of what son may do to her). I strongly support this legislation and respectfully request immediate passage of this bill.
