My name is Kaliko Amona and am the director of the Kokua Hawai'i Foundation's 'AINA In Schools Program, a farm to school program dedicated to connecting children to their land, waters, and food in order to grow a healthier Hawai'i. I also represent the National Farm to School Network as the Hawai'i State Lead. Together with organizations such as the Hawai'i School Garden Hui, which includes School Garden Networks on Kaua'i, O'ahu, Maui, and Hawai'i Island, as well as the Hawai'i Association of Independent Schools' Grow Hawai'i Farm to School Initiative and the Healthy Hawai'i Initiative, we are working to promote the farm to school and school garden movement in the state.

In 2010, the United States Congress passed House Resolution 1655, which established October as National Farm to School Month. - · Senate Bill 19, *The Pupil Health*, *Nutrition*, and *Achievement Act* (2001) identifies school gardens as one way to increase student preferences for fresh fruits and vegetables.
- · Assembly Bill 1634, *Nutrition Education* (2002) further supports school gardens through identifying best practices and supporting a grant program.
- Assembly Bill 1535, *California Instructional School Garden Program* (2006) authorizes the CDE to award \$15 million for grants to promote, develop, and sustain instructional school gardens.

The "Garden in Every School" program has resulted in over 3,000 gardens in the state. This is a program with wide reach and is proven to effectively enhance education and health of our students and communitties.

Honored Legislators;

As a parent of two children at Kainalu Elementary School, the Co-Sponsor for the afterschool 'AINA IS Garden Club, and a nutrition docent for the farm to schools program at Kainalu, I strongly support House Bill 1475.

In the garden club, I see 20 or so keiki every Friday afternoon, along with several parents, teachers, and pre-school siblings tending our gardens. This group works their heart out to create a beautiful natural space that is respectful of the 'aina and brings vibrant life and beauty to our school. They learn how to measure and create, while building Pulelehua enclosures with wood and screening, and constructing an irrigation system from donated materials that they have measured and planned. They learn lessons in biology and ecology as they carefully monitor the Monarch butterfly lifecycle; from egg, to caterpillar, to pupae, to adult, releasing our first batch of butterflies grown from caterpillars last Friday. They dig into the soil to plant and nurture seeds that will actually produce food for harvest. This is a tangible relationship with our earth that, built in the farm to schools program, will last a lifetime.

As a nutrition docent, there have been real signs of success. When I have entered the cafeteria, several second graders call to me to let me know they are eating "close to the source". Recently, when I walked into school with a Dr. Pepper, I came upon a student that looked at me sideways and said, "Mrs. Heggarty, that looks like a "caution food." I think you could make a better choice."

One particular moment that gave me great pride, was when a teacher assistant announced that a finicky student (with special needs) tried each ingredient of our bird's nest salad. This included cabbage, grapes, and carrots. This student had a diet that was previously very limitied, and had never tried any of these healthy foods before the day we visited the class. THAT was a real moment to celebrate.

Cafeteria waste is reduced by composting. Hands-on learning is extremely fun and valuable. Television and video games are set aside. Kids look at, listen to, touch, smell and taste the outdoors. Agriculture becomes a joyful endeavor. Healthy eating is celebrated.

It would be great for this news to spread, for the programs to grow, and for young people to continue to care for the land and its inhabitants in a way that will maintain a healthy culture and foster sustainability.

Chair Tsuji, Vice Chair Hashem and Members of the Committee:

My name is Douglas L. Vincent and I am a Department Chair with the Department of Human Nutrition, Food and Animal Sciences, with the University of Hawaii at Manoa's College of Tropical Agriculture and Human Resources (CTAHR). I am pleased to provide personal testimony on HB1475. I support the passage of HB1475. This testimony does not represent the position of the University of Hawai'I, of CTAHR or my Department.

As the primary author of the Farm-to-School Report to consider the feasibility of establishing a statewide farm-to-school program in Hawaii's public schools for the 26th Legislature, in response to SCR121 SD1 HD1, SLH 2009, I have reviewed and studied farm-to-school programs throughout the United States.

The 2003 Hawai'i Food Security Task Force reported that over 19% of Hawai'i residents live in food insecure households and most of these households contain school-aged children. Food insecurity contributes to obesity rates. Many school children have limited exposure to the wide range of healthy, locally-grown foods that are available. School children frequently have no idea where food comes from or how it is prepared and are susceptible to the easy availability of "junk" food that surrounds them.

Farm-to-School programs, including school gardens, are innovative educational programs that can provide our children with opportunities to learn about and eat the highest quality, local food that not only nourishes children's bodies immediately, but also provide knowledge that enhances their educational experience and cultivate long-term healthy eating habits. HB 1475 would designate October as Farm-to-School Month and bring recognition to the programs throughout the State that are striving to improve our keiki's health and well-being. I support HB 1475.

My name is Ilana Stout and I am a teacher at Kea'au High School. I am writing to declare my support of House Bill 1475, creating Hawaii Farm to School Month.

I taught Food Science and Nutrition at Kea'au for 3 years and was shocked to discover how little high school students understand about not only nutrition, but where our food comes from. Many of the teenagers that I work with eat diets that consist largely of packaged, processed foods and don't consider the path that those foods take to get to them. At the beginning of the year I pose the question, "Where does our food come from?" to my students. Answers may include "the store", "the gas station" or "McDonalds" but very rarely include the farmers markets, local farms or the aina itself..

It is not that students are unaware of the existence of farmers market and agriculture in our community, but flashy advertising and marketing of processed foods appeals to them so directly that "slow food" seems irrelevant and unimportant. Students suffer from a lack of connection to real food and real farmers. They are dependent upon the media to tell them what to eat, and the foods that are being pushed at them are largely high in sugar, salt, fat and empty calories.

Farm to School programs are organized in many different ways and can offer students a myriad of academic, nutritional and character lessons. They offer students an opportunity to learn more about nutrition and provide a meaningful understanding of the cycles of matter and energy. They can provide students hands-on learning opportunities in real world environments and can be invaluable experiences for students who choose to pursue a career in agriculture. They provide cafeteria managers with high quality ingredients and students with healthy, delicious food. They can provide markets to help local farmers sell their products. And perhaps most importantly, these programs instill in students a sense of stewardship for the earth, for their communities and for their own bodies.

Supporting HB1475 is an investment in our keiki's future and for the future of Hawaii. We cannot continue to rely on imported food when much of it can be produced here in the islands. I only buy Hawaii's Best Milk when possible because it is locally produced on the Big Island. My kids can taste the difference between imported organic milk and local milk. We don't eat a lot of beef, but when we do, we try to purchase locally raised beef as well. Land is the most important commodity in our islands and we need to teach our kids that a farm is a contributing assets in our community versus a sprawling development.
