PRP is in support of HB 1505, HD2 - Relating to State Facilities which establishes the State Facility Renovation Partnership Program.

Hawaii's economy is still trying to emerge from the great recession that struck the United States back in 2008. The weak economy severely reduced all forms of revenue collected by the State. Because of its revenue shortfall, the State has found it difficult to construct new infrastructure, including buildings and other facilities. In light of these circumstances, public-private partnerships have emerged as a promising, viable alternative model and are predicted to gain even greater prominence and popularity in the future.
