## Testimony of the Office of the Public Defender State of Hawaii to the House Committee on Judiciary

March 3, 2011

H.B. No. 1524 HD1: RELATING TO AGRICULTURAL THEFT

Chair Keith-Agaran and Members of the Committee:

We have concerns regarding H.B. No. 1524 HD1 which creates a prima facie case for theft if a person is found in possession of more than five pounds of an agricultural product even if the product was possessed on the premises in question. We are concerned that this provision shifts the burden of proof from the state of the defendant. Although a prima facie case does not equate to proof beyond a reasonable doubt, it does place the burden on an accused to present some amount of evidence to prove his/her innocence.

The fear is that this provision can be used by property owners against disfavored employees if those employees possess the amount of agricultural products specified in the bill. These employees can then be arrested, terminated from employment, and be forced to hire an attorney to defend themselves even though the possession of products may have been innocent.
