Chair McKelvey, Vice-Chair Choy and Members of the Committee.

The Department of Business, Economic Development, and Tourism (DBEDT) offers the following comments on HB1551, which seeks to increase the existing Motion Picture, Television and Digital Media refundable tax credits and amends HRS 235-17 to include infrastructure project income tax credits, an additional tax benefit for special effects or animation production in any county of the state, a qualified local crew training program rebate and an exemption from the transient accommodations tax after thirty days of Hawaii expenditures.

At this juncture, we do not recommend altering HRS 235-17 as it exists currently, as it is critical to provide stability of the credit going forward. We agree that the development of digital media infrastructure credits, workforce development, special effects, post production credits and the other ideas presented in HB1551 are worthy of further discussion and welcome the opportunity to dialogue with industry and lawmakers going forward. We defer to Department of Taxation on the fiscal impacts of the measure as well as its impact on existing staff that would be required to manage the additional proposed credits.
