Aloha Chair Takumi, Vice Chair Belatti and Committee Members:

On behalf of the Hawaii Technology Academy (HTA), a public charter school with learning centers in Waipahu and Princeville serving students on Oahu, Kauai, Hawaii Island and parts of Maui, thank you for the opportunity to testify in support of this bill.

We support HB 159, which establishes a funding formula for charter school facilities.

This bill is an outcome of the collaboration from the Charter School Funding Task Force (established by SCR 108), to look at detailed information on existing funding sources for charter schools, look at the Department of Budget and Finance's calculation for DOE and charter school per pupil allocations, review discrepancies between these allocations, and examine whether a portion of the debt service, repair and maintenance and capital improvement expenses should be paid by charter schools.

We would like the opportunity to collaborate with members of this committee and other hybrid schools like HTA to provide information about average facilities funding costs needed to support hybrid or "distance-learning" facilities. HTA uses technology to deliver Science, Technology, Engineering, the Arts and Creative Media, and Math-focused curriculum through online and face-to-face instruction with our teachers. As such, we do have certain space and facilities requirements that are unique to online learning.

For these reasons, we respectfully request to provide members of the committee with additional information to help refine this bill for passage.
