### **RELATING TO VOTING**

March 1, 2011

Chair Oshiro and members of the House Committee on Finance, thank you for the opportunity to testify on House Bill No. 1613, HD 1. The purpose of this bill is to provide for the application to register to vote to include a space to request a permanent absentee ballot. Additionally, the bill provides that a voter may request an absentee or permanent absentee ballot at any time but not later than 4:30 p.m. on the seventh day prior to an election.

Given that the bill would require the creation of a new form, the Office of Elections requests that it include appropriation language in the amount of \$57,000. This amount would cover the design, minority language translations required by federal law, and printing costs associated with the new form.

Statement of Al Hamai, President, in Support of HB1613, HD1, Relating to Permanent Absentee Voting

## **Hearing of House Finance Committee**

Chair Marcus R. Oshiro, Vice Chair Marilyn B. Lee and Members of the Committee,

I'm submitting this testimony on behalf of HARA, urging your Committee to approve HB1613, HD1, relating to permanent absentee voting.

The purpose of this bill is to require that the form for an application for voting include a request for a permanent absentee ballot, and also to expand the short window period that a citizen may apply for a permanent absentee ballot. That period is too short and restrictive.

Back in 2008 you and the other members of our state Legislature voted, overriding a veto by Governor Lingle, to authorize permanent absentee voting, a very forward-looking effort to encourage greater voting by making voting easier for seniors and other citizens. Consequently, more and more citizens are taking advantage of this law, as attested by the increasing number of absentee votes cast. Yet our election turnout is still low and adoption of this HB1613, HD1 will encourage greater participation.

We need to make it easier for citizens to register for permanent absentee voting by including on the application for voting, language where an applicant may indicate that he wants to also apply for permanent absentee voting, making it a simpler process. And if approved, could eliminate or reduce the paperwork by staff in the voter application process.

The state Elections Office and the various counties have attractive websites on voting and include the forms for Voter Registration, Absentee Voting and Permanent Absentee Voting that can be downloaded on-line. These forms are easily accessible.

We believe that the cost of changing the form online is surely not prohibitive, requiring a huge budgetary allocation. Routinely, we revise our own personal and organizational forms with simple additions and deletions, taking a few seconds to a couple of minutes. So a simple form revision should be easy for the existing staff.

Later, the new revised forms could be reprinted when current supplies run out and reprinting is a normal expense.

We believe that akamai election administrators, with the plodding of this legislature, can find a way to revise the Voter Registration form to include a request for a permanent absentee ballot, and also to expand the short window period that a citizen may apply for a permanent absentee ballot, without incurring expenses that require the approval of this Committee and the Legislature.

We concur with the purpose of HB1613, HD1, which seeks to make the application for permanent absentee voting a much easier process, and which could encourage more of our electorate to vote in the comfort of their homes. We urge your Committee to approve this bill.

## Aloha House Financial Committee Members,

I urge you to vote in favor HB1613, HD1 in order to eliminate the annoying roadblocks the current law places in the way of citizens who wish to vote by Permanent Absentee Ballot.

From an implementation cost perspective, I strongly believe that the changes needed to implement this bill can be done without any additional cost or budget impact by making the website and software changes as part of normal maintenance and only printing new updated forms as the old forms run out and new forms need printing.

Just a couple of years ago the Legislature granted us the privilege of being able to vote permanently by absentee ballot, but, as any PAB voter will tell you, it is not easy to obtain PAB voter status today.

Now, almost half of all participating voters vote absentee. I am convinced that most of any future increase in voter participation will come from Permanent Absentee Ballot voting because it takes less time, is less physically challenging and does not require constant reapplication for an Absentee Ballot.

In order to get more citizens to voter we need to eliminate these annoying roadblocks to obtaining permanent absentee voter status:

<u>Currently you cannot apply for Permanent Absentee Voter status on the</u>
 <u>WikiWiki Voter Registration form</u>. You must apply separately on Permanent
 Absentee Ballot form and then only mail in that form within the very narrow PAB
 form acceptance window.

 PAB forms are currently only accepted "no earlier than 60 days and no later than 7 days prior to the election

New voters are probably not all that familiar with voting in Hawaii either because they are young inexperienced voters or new to our state's voting procedures yet we make them navigate these complex roadblocks to easy convenient voting.

You have to be one determined new voter to get registered to vote by Permanent Absentee Ballot in Hawaii. And, the narrow acceptance window for more experienced voters makes voting by PAB a pretty tricky endeavor as well.

I ask that you please vote in favor of HB1613, HD1 so that voting by Permanent Absentee Ballot can finally provide the originally intended easy convenient way of voting!

I am very concerned that there must be some misunderstanding of this proposed bill in the testimony Chief Elections Officer Scott T. Nago submitted for the JUD hearing on HB1613:

Here is what Chief Elections Officer Scott T. Nago wrote:

Aquot; Given that the bill would require the creation of a new form, the Office of Elections requests that it include appropriation language in the amount of \$57,000. This amount would cover the design, minority language translations required by federal law, and printing costs associated with the new form.

Maui County Clerk Jeffery T. Kuwada submitted similar testimony to JUD but with not cost estimate:

" The bill (HB1613) will require the creation of a new form. The Clerk's Office is not in a position to presently estimate the cost of creating the new form. The cost will include, but not be limited to, design of the new form, translation of the form into minority languages required by federal law, and printing costs"

Again, there must be some misunderstanding of this bill on Maui as well.

To implement HB1613, HD1 all that is required is the adding of a tick box allowing the person filling out the WikiWiki Voter Registration form to elect to vote by Permanent Absentee Ballot.

The creation of no new forms is required and all of the information on the WikiWiki Voter Registration Form is sufficient information to also meet the Permanent Absentee Ballot registration requirements.

It is inconceivable that it will cost the State of Hawaii or the Counties \$57,000 to add a tick box to an existing form.

Given the tight budgets constraints the State is under and in the spirit of wanting to make it easier for our citizens to participate by voting I can see no reason for this measure to require any new budget implementation funds whatsoever.

.B1613, HD1's tick box could be added as part of the normal maintenance to the Office of Elections website as the from is there as a downloadable .PDF file. The paper Wiki Wiki Voter Registration form could be modified in seconds and only reprinted when the existing supply of forms runs out.

I strongly urge the House FIN Committee to approve HB1613, HD1 with no budget allocation whatsoever because I feel certain that little or no money is needed to add one tick box to an existing and well known form.

As for the translation costs, I will be happy to translate the term "Permanent Absent Ballot" and any needed explanations/directions needed to meet the

" minority language translations required by federal law"

for free in the spirit making it easier for registered voters to vote, which was the intention of the PAB law when it was enacted a couple of years ago over Governor Lingle's veto!

While I am are mentioning language translation, I am still wondering why it is that you can vote in Hawaii in several different languages but not it Hawaiian, that is not pono.

I would like to thank Rep. Della Au Belatti for championing this important Good Government measure and Speaker Say and the other 36 House Members for co-sponsoring HB1613.
