The purpose of this bill is to establish a licensing requirement for large scale dog breeders to regulate the transportation, sale, purchase, housing, care, handling, and treatment of dogs by large scale breeders to ensure that the dogs are provided with humane care and treatment; and protect the public from purchasing unhealthy dogs. The bill also allows for inspection by the Department of Commerce and Consumer Affairs to ensure compliance, and provides civil and criminal penalties for violations of the law.

I am writing in support of HB1621 which would mandate licensing of large scale breeders.

This bill is a critical one to address not only the care of Hawaii's animals but it would also help address overpopulation issues as well. Regulation of large scale breeders is long overdue.

### Dear Representatives,

I want to present my testimony for House Bill 1621, Regulation of Large Scale Breeding Operations. I am in support of the bill because we need to crack down on irresponsible breeding purely for profit with disregard for the welfare of the parent animals. Responsible breeders take care to limit the number of times a female gets pregnant so she is not constantly producing puppies, but has adequate time between pregnancies to recover and be healthy without having puppies to feed. Responsible breeding is taking care that females do not pregnant when they are too young or too old, even if capable of bearing puppies. Responsible breeding includes what most pet owners consider regular care, including appropriate housing, regular access to outdoors, and certainly veterinary care. Responsible breeders care for their breeding animals the same as they would a member of their family. Many large scale breeding operations do not provide this basic care for their females (or males for that matter). Many times the females suffer greatly in small cages their whole lives without so much as basic veterinary care, but as long as they are producing puppies that can be sold, they are of value, regardless of the poor state of the animal. More regulation would cut down on such operations and provide appropriate care for the animals.

I hope to see this bill take effect so inspectors can get into puppy mills and improve the livelihood of animals whose only purpose is to pop out puppies to be sold.

# Regulation of Large Scale Breeding Operations (House Bill 1621)

This bill would mandate licensing of large scale breeders, which would be defined as follows: any business operation with 20 or more breeding females; or 30 breeding dogs of either gender; or an operation that sells 25 or more puppies a year. This bill aims to set a cap on total number of breeding animals at 50 and limits the number of times a female can be bred to twice in an 18-month period. It also sets minimum standards of care to include indoor and outdoor access and annual veterinary care. This bill also enables law enforcement the access needed to provide inspections to assure the welfare of animals. For more info on puppy mills click here.
