SUBJECT: Testimony on H.B. No. 258, H.D. 1, Relating to Campaign Spending

Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") strongly supports this bill and urges the Committee to pass the bill.

The 2012 primary election will be held on August 11, 2012. The election was advanced to the second Saturday in August (from the second to the last Saturday in September) pursuant to Act 126, SLH 2010 ("Act 126"). Act 126, however, did not change any filing deadlines for disclosure reports.<sup>1</sup>

The purpose of this bill is to maintain transparency of campaign spending.

- This would be accomplished by aligning the filing deadlines for candidate committee reports with the earlier primary election date.
- Moreover, campaign spending information should be available at approximately the same intervals that information was available under the prior statute to provide access to current campaign spending information. This would be accomplished by a candidate committee and noncandidate committee filing one additional report.

More specifically, section 1 of the bill amends subsection (a) of §11-334 (Time for candidate committee to file preliminary, final, and supplemental reports) as follows:

- Changes the deadline for filing the first preliminary primary report from July 31 to July 5;
- Adds a requirement to file a first preliminary general report on September 30; and

• Adds a new subsection (c) to address a gap in Act 211 and the prior statute. An individual who is a "candidate" before an election year is not subject to reporting requirements until the election year begins. This provision would require a "candidate" to file reports before an election year.

Section 2 amends subsection (a) of §11-336 (Time for noncandidate committee to file preliminary, final, and supplemental reports) because of the change in the primary election date. This bill adds a requirement to file a first preliminary general report on September 30 (same as the change for a candidate committee proposed in section 1 of the bill).

In Part I of our testimony we discuss candidate committee reports; and in Part II we discuss noncandidate committee reports.

#### I. CANDIDATE COMMITTEE REPORTS

# A. Reporting deadlines under Act 126, SLH 2010

Reports must be filed in the 2012 election year by candidates for the House of Representatives, Kauai Mayor and Neighbor Island County Council<sup>2</sup> as follows:

- Under Act 126, the reporting deadlines for the first preliminary primary report and second preliminary primary report are only one day apart (July 31 and August 1, respectively).
- There also is a 59-day gap between the <u>August 31, 2012</u> deadline for the candidate committee's final primary report and the <u>October 29, 2012</u> deadline for the preliminary general report. There would be less transparency because current campaign spending information would not be available during this gap. During the peak of the 2010 election, by contrast, the time-period between the regular candidate committee reports filed varied from seventeen to thirty days. Reports were due in 2010 on September 8, October 8, and October 25.

# B. Reporting deadlines under this bill

In order to address the concerns above, this bill proposes<sup>8</sup> that candidate committees file reports in the 2012 election year as follows:

Reports must be filed by a noncandidate committee in the 2012 election, pursuant to Act 126, as follows:

There will be a 59-day gap between the <u>August 31, 2012</u> deadline for the noncandidate committee's final primary report and the <u>October 29, 2012</u> deadline for the preliminary general report. There would be less transparency because current campaign spending information would not be available during this gap. During the peak of the 2010 election, by contrast, regular noncandidate committee reports were due on October 8 and October 25.

In order to address the concern above, this bill proposes<sup>14</sup> that noncandidate committees file reports in the 2012 election year as follows:

Lastly, section 4 of this bill provides that the effective date is January 7, 2050. The Commission would like to note the importance of the bill to take effect on approval based section 1 which changes the deadline to file a candidate committee's first preliminary primary report from July 31 to July 5 as a result of the new earlier primary election date.
