Chair Oshiro, Vice-Chair Lee and Members of the Committee:

I submit testimony in my capacity as a Member of the Hawai`i State Board of Education (BOE) in strong support of HB338 hd1, which would require that one of the voting members on the BOE, be a student.

# TESTIMONY ON HOUSE BILL 338, HOUSE DRAFT 1, RELATING TO EDUCATION

Honorable Chair Oshiro and committee members:

I am Kris Coffield, representing the Imua Alliance, a nonpartisan political advocacy organization that currently boasts over 60 local members. On behalf of our members, we offer this testimony  $\underline{in}$  support of HB 338, relating to education.

It is time to stop the continued marginalization of the Board of Education's student member. Early versions of legislation creating an implementation process for an appointed school board, from which HB 338, HD1, is taken, extended voting privileges to the student member, rewarding students who have repeatedly demonstrated an eagerness to exercise civic responsibility when afforded the opportunity, as evidenced by the success of programs like Kids Vote Hawaii. Moreover, 70 percent of high school students polled in a 2008 survey favored enfranchising the student member, except on personnel matters, a step already taken by states as varied as California and Vermont, both of which have appointed school boards. Given that students are the primary stakeholders in the state's education system, the school system's intent to foster civic engagement, and the differentiated perspective offered by students impacted at the classroom level by changes made to the educational process, it seems logical to enfranchise the board's student member, except, again, on personnel matters.

As mentioned by delegates from the Department Education's Secondary Student Conference at a recent hearing on an appointed school board, at which this issue was discussed, public school students constitute 15 percent of the state's population, yet receive no vote. As SSC's representatives indicated, several hundred of these students—in particular, students from Kalaheo High School—have signed a petition calling for enfranchisement. Concerns were raised regarding the safety of the student member in the event of controversial votes and the extent to which the member speaks for all public school students. Such concerns are misplaced, however, for several reasons. In this case of student safety, the student member is covered by Hawaii state law, including §8-19, which defines policies relating to student conduct. Thus, the student member is incorporated into a class of citizens already afforded special status because of their age. Thus, to assert that public service places the student member in

danger, one must also conclude that students are so heavily vested in public affairs that they're willing to literally fight for their views or police and school administrators are incapable of carrying out basic security functions. With regard to representation, allowing the governor, instead of the Hawaii State Student Council, to appoint the student member ensures that he or she will have the same accountability as all other appointed members, and brings the selection process into consonance with other governing bodies that include such members, like the University of Hawaii Board of Regents.

Again, Imua Alliance urges the committee to recognize the unique place of students in the educational process by extending voting rights to the Board of Education's student member. Now is not the moment to discard the fierce beliefs of our state's youth, but is, on the contrary, the time to bring those voices into the fold, incorporating them into discussions about how to prepare our state for an increasingly competitive future. Mahalo for the opportunity to testify in support of this bill.


