Chair Oshiro and Committee Members:

I am Edward Teixeira, Acting Director of Civil Defense, State Department of Defense. I am providing written testimony on House Bill 505 HD1.

During past flood disasters including the recent heavy rains and flooding caused by severe weather on January 12-14, 2011, State Civil Defense, Department of Defense, has witnessed repetitive flooding in areas along Farrington Highway between Ma'ili and Nanakuli and also in areas inland where poor roadside drainage has contributed to flooded homes, farms, and ranches.

We appreciate the Legislature's interest in addressing repetitive flooding along Farrington Highway through an appropriation for flood hazard mitigation projects. State funds should be appropriated to address repetitive flooding problems in the Lualualei Watershed area. We therefore support the intent of this bill so long as it does not replace or adversely impact priorities as established in the Executive Biennium Budget Request.

We defer to the Department of Transportation for additional comments in support or opposition to House Bill 505 HD1 with respect to Farrington Highway.

Thank you for the opportunity to provide written testimony on this bill.

TITLE: RELATING TO FLOOD MITIGATION

<u>DESCRIPTION:</u> Appropriates funds for flood mitigation on Farrington Highway between Maili and Nanakuli.

<u>POSITION:</u> The Department of Transportation (DOT) supports this Bill, so long as it is accompanied with an independent appropriation that does not impact the DOT's capital program budget and the priority of projects, therein.

Flooding along Farrington Highway between Nanakuli and Maili has been an ongoing issue during periods of heavy rainfall. Our Highways Division's maintenance staff is well aware of the flood occurrences and removes debris from the highway as well as performs inspections of the existing drainage system during and immediately after a major rainstorm.

The appropriation of funds to prepare a feasibility study that include drainage improvement alternatives, costs associated with these alternatives will be most desirable. The results of the feasibility study shall determine additional funds necessary for the design and construction of drainage improvement projects in the area.

Drainage improvements will not only alleviate flooding and improve road conditions during inclement weather but will reduce maintenance costs for the Highways Division.
