I have been a farmer for as long as I can remember. I now own the only dairy on the island of 'Oahu, Naked Cow Dairy. I own and operate an all female boutique dairy with my family in Waianae. Our products include butter, cheese, and yogurt. We make deliveries to Honolulu about 4 times a week and also participate in The Hawaii Farm Bureau's Farmers Markets around the island 5 times a week. I know our economy is having hard times right now, but we try our best to maintain. At the moment my business is just getting by. Everything is just too expensive.

If we miss even one delivery or miss a Farmer's Market my business is greatly affected. There is only one way in and out of Waianae and there have already been incidences where Farrington Highway has been shut down. When you work on a farm, the work never ends. You live at work! I wake up at 4 am every morning to work on my farm and after that, I either have to make deliveries or go to a Farmer's Market. By the time we leave the markets and head home, there is still traffic coming into the Waianae Coast due to on-going construction between Ko Olina and The Power Plant.

It is eminent that there is an alternate road out of the Waianae Coast. If Farrington Highway were to shut down, there would be no way for the people who live out in the district to get home. The only other way into Waianae is through Kolekole Pass and the only way to enter Kolekole Pass is through Wahiawa. Waianae needs an alternate access road. I hope that you do not wait for the event of an emergency to occur before a road is built. Thank you for your time and consideration.

I work near Diamond Head so I have a very far commute every morning, which I don't mind as long as I can keep a roof over my family's heads. We are a very busy and active family. All my children play sports. My two older children play sports for their schools and my youngest plays sports at The Waianac District Park three times a week. We are also very active in our Church, The Church of Jesus Christ of Latter-day Saints.

On a good day, I finish work around 5 pm. Then I have to pick up my two older children from practice and the journey home begins. At 5 pm traffic is horrendous.
