Chair Espero and members of the Senate Committee on Public Safety, Government Operations and Military Affairs, Mayor Peter Carlisle submits the following testimony in support of H.B. 587, H.D. 2. H.B. 587, H.D. 2 is a bill proposed and supported by the Hawaii Council of Mayors which is comprised of the Mayors of Maui, Kauai, Hawaii and the City and County of Honolulu.

The purpose of this bill is to amend Hawaii Revised Statutes (HRS) section 281-11.5 to provide that county liquor administrators be appointed and removed as prescribed by each county charter. Under Article VIII, Section 2 of the Constitution of the State of Hawaii, the counties have the authority to adopt charter provisions on their executive, legislative and administrative structure which shall be superior to statutory provisions subject to the authority of the legislature to exact general laws allocating and reallocating powers. All four counties have adopted a charter provision regarding the appointment and removal of a county liquor administrator and this bill would harmonize the statute with the charter provisions.

H.B. No. 587, HD2 Relating to Counties

The Hawai'i Council of Mayors (HCOM) supports H.B. No. 587, HD2, which provides that the county liquor administrators be appointed and removed either by each county's liquor commission or as prescribed by their charters. The Bill also shifts the ancillary powers of the liquor administrator from H.R.S. §281-17 to H.R.S. §281-11.5.

The Hawai'i State constitution, Article VIII, Section 2, authorizes the counties to frame and adopt a charter for their own self-government. H.B. 587, HD2 clarifies and reinforces this basic "home rule" doctrine.
