In other words, two years ago they were "penny wise and a pound foolish". I support the language in the bill to read, "Individual patient service shall be based upon the level of function and need of the patient and not upon initial predetermined limitation of service hours."

If we are about developing communities of people, if we are about a "New Day in Hawai'i", we must not employ only trained professionals, clinical social workers. Wai'anae citizens have continuously over thirty years worked with the Department of Health and now the University of Manoa, and Community Colleges and requested that training of para-professionals be the ladder communities have access to climb out of poverty and solve our own social problems.
