HB 625 HD2 RELATING TO EDUCATION

Chair Oshiro, Vice Chair Lee, and members of the Committee:

The University of Hawaii at Manoa's College of Education supports HB 625 HD2.

The University understands that there are a number of vacant buildings in the possession of public schools. Given that these buildings are standing empty, it is rational to institute procedures to return those buildings to constructive use.

Friendly Amendment:

However, we would like to suggest a friendly amendment to the bill. While priority first goes to charter schools and other educational programs, we think the bill should explicitly indicate *public* charter schools and other *public* educational uses as top priorities. In the current language, the buildings should be offered to "other education programs," which could include private, non-profit, or alternative users. If the legislative intent is for public educational use, we would recommend being explicit in that language. If non-public educational use is also intended, then those options should exist only after exhausting all public charter school and public educational options. Following exploration of possibilities for educational use, we would support the buildings being offered to the county, preferably for public use.

House Bill 625, House Draft 2 requires the Chairperson of the Board of Land and Natural Resources (Chairperson), upon recommendation and approval of the Department of Education (DOE) Superintendent, to accept the transfer from the DOE to the Department of Land and Natural Resources (Department) any state land under DOE's jurisdiction and set forth priorities for alternate uses. The Department supports this measure, but offers the following comments

In particular, the Department supports the amendments to Section 171-19, Hawaii Revised Statutes, proposed in House Bill 625, House Draft 2. Once lands are returned to the Department, proceeds resulting from future dispositions of the lands would support the Department and the Special Land Development Fund (SLDF). The SLDF provides financial support critical for the Department to fulfill its fiduciary duty, including but not limited to the management and preservation of the State's cultural, historic and natural resources.

However with respect to Section 2 of the bill, although the Department does not object to Counties having priority over the State for lands the Counties holds the fee title, the Department does object to the Counties having priority over the State for those lands held in fee title by the State of Hawaii. Accordingly, the Department recommends the following amendment to Section 2 of the bill that would make clear that the Counties would have priority over those lands in which they own the fee.

"2) The county where the land or building is located; provided that the county is willing to accept the land and the land is held in fee title by the county and was previously under the jurisdiction of the county."

Aloha Chair Oshiro, Vice Chair Lee and Committee Members:

On behalf of the Hawaii Technology Academy (HTA), a public charter school with learning centers in Waipahu and Princeville serving students on Oahu, Kauai, Hawaii Island and parts of Maui, thank you for the opportunity to testify in support of this bill.

This bill requires land and facilities under the jurisdiction of the DOE not being used to be transferred to the DLNR; provided that the land or facilities is first offered to, or used for charter schools, other educational purposes, or to an eligible county where the land or facility is situated.

We support legislation authorizing public charter schools to have first access to all or a portion of DOE school facilities in the event of a closure. Currently, many start-up public charter schools must go into the market to find and renovate commercial space to accommodate classroom, library and other work space to support an environment for learning. This investment in facilities is costly and must be balanced along with providing curriculum, personnel costs and other expenses required to run a school.

HTA is one of Hawaii's 31 public charter schools that are part of the state public school system. Like Hawaii DOE schools, charters comply with federal and state education standards. We support efforts like this to improve Hawaii's public education system.

For these reasons, we respectfully request for the committee's support of this bill.

Aloha, my name is Megan McCorriston, executive director of Hoʻokākoʻo Corporation (HC), a 501(c)(3) charter support organization that serves as the local school board for three public conversion charter schools — Waimea Middle School on Hawaiʻi Island, Kualapuʻu Elementary School on Molokaʻi, and Kamaile Academy in Waiʻanae — which educate nearly 1,600 students, or roughly 19 percent of the total public charter school student population in Hawaiʻi.

Hoʻokākoʻo Corporation supports House Bill 625, House Draft 2 – Relating to Education, which proposes to make land and school facilities under the jurisdiction of the Hawaii Department of Education (HIDOE) that are unused for school purposes available for the use of public charter schools and other educational programs.

All of HC's public charter schools share a vision of a comprehensive educational experience that involves a rich offering of academic and enrichment programs and a variety of learning environments for learners of all ages. Although each of HC's public charter schools has its own unique plan for making this vision a reality, all three schools — as well as the students, families, and communities that they serve — have a strong interest in expanding their instructional space and the number of grade levels that they teach; however, the growth and development of these schools, like the rest of the State's public charter schools, are severely constrained by the availability of land and facilities.

By giving public charter schools an opportunity to make use of unutilized HIDOE land and any of its pre-existing school buildings and facilities, HB 625 HD2 would not only keep land designated for educational purposes in active use by public schools, but it would also open up significant possibilities for the growth of all of Hawai'i's public charter schools.
