TESTIMONY IN SUPPORT OF INTENT

Re: H.B. 734 Relating to the Economic Opportunity Poverty Reduction Task Force

Good Morning Chair Mckelvey, Vice Chair Choy, and committee members. My name is En Young of the Office of Community Services (OCS), an agency administratively attached to the Department of Labor and Industrial Relations (DLIR). We appreciate this opportunity to testify in support of the intent of this measure.

The reduction of poverty is an issue that continues to transcend our State's traditional program organization. Programs such as The Emergency Food Assistance Program (TEFAP) and Employment Core Services (ECS) in DLIR, SEE and First-to-Work in DHS, WIC in DOH, and even School Lunch Subsidy Programs in DOE all contribute to the economic self-sufficiency of our low-income residents in different, yet meaningful ways. We believe the infrastructure exists to tackle each individual aspect of a low-income person's basic needs.

What we lack, at many levels of government, is the communication and coordination of government agencies, between Departments, between Executive, Legislative, and Judicial

branches, and between providers of the direct services to alleviate the conditions that perpetuate this circumstance.

OCS is concerned that the task force proposed is comprised only of Legislative members. We respect the introducer's idea of creating a concrete, measurable goal of a fifty per cent reduction in poverty in the next ten years. With all due respect a panel of Legislators will be insufficient to provide the insight and experience necessary to make true progress toward this goal. We are additionally concerned that by tying poverty to the Federal definition, fluctuations in poverty guidelines proposed by Congress could increase or decrease the number of poverty stricken individuals with absolutely no correlation to improvements or failures in the State's implementation.

OCS whole-heartedly supports the creation of a plan to increase economic opportunity. To this end, OCS plans to leverage Federal funding to host a statewide conference bringing together stakeholders from public, private, and non-profit sectors sometime later this year to create just such a plan. We would appreciate any participation or expertise your members may be able to provide and will keep the Legislature apprised of progress toward this measurable.

To provide some context for this conference, you may be aware OCS was created to consolidate four key programs within the state, one of which was the Office of Economic Opportunity. Additionally we are charged, under HRS 371K-3 to "Serve as the principal official in state government responsible for the coordination of programs for the needy, poor, and disadvantaged persons..." and under HRS 371K-4, among other duties, to "Establish statewide goals and objectives relating to disadvantaged persons, refugees, and immigrants..." With this in mind, OCS believes it is the right office and now is the right time to reassess this challenge that is becoming increasingly salient in the wake of the recession.

Finally, we believe the creation of a task force would most likely be better introduced as a resolution, rather than codified in Statute.

The Hawai'i Alliance for Community Based Economic Development (HACBED) is submitting testimony in **support of HB 734** which establishes an economic opportunity poverty reduction task force.

We thank you for considering the creation of a task force that would: 1) assess current state policies and practices, along with evidence-based solutions utilized in other states, that promote economic opportunity and poverty reduction; and 2) develop a plan to expand economic opportunities in Hawaii to reduce the number of families in poverty.

As families and communities struggle to get through these hard economic times, a joint legislative task force that seeks strategies to reduce poverty in Hawai`i, with a goal of reducing poverty by at least 50 percent by 2021, is very much needed to help families reach self sufficiency and move out of poverty.

Across the nation, asset building has proven to help families move out of poverty.
