Chairpersons Tsuji and Members of the Committee:

Thank you for this opportunity to provide testimony on House Bill No. 865, Relating to Inspection Fees.

The purpose of this Act is to increase the fee assessed for the inspection, quarantine, and eradication of invasive species contained in any freight from 50 cents to \$1 for every 1,000 pounds of freight brought into the State. The Plant Quarantine Branch's inspection and Biosecurity program is the only mitigation at the ports statewide for invasive pest introductions. While the Department is inclined to support further discussion about the intent of this bill, we decline to comment at this time due to ongoing litigation.

In consideration of HOUSE BILL 865 RELATING TO INSPECTION FEES

House Bill 865 increases the fee assessed for the inspection, quarantine, and eradication of invasive species from 50 cents to \$1 for every 1,000 pounds of freight brought into the State. The Department of Land and Natural Resources supports House Bill 865 and the collection of these fees. The State's authority to adequately finance inspection of incoming cargo is essential to protecting Hawaii residents, resources, air passengers, and airport facilities against harmful cargo arriving in the State. The imposed fee is reasonable as it is imposed on marine commercial container shipment, air freight, or any other means of transporting freight, foreign or domestic, but does not include aggregate bulk freight, cement bulk freight, coal bulk freight, or liquid bulk freight, that is brought into the State.

Chair Tsuji and Members of the House Committee on Agriculture:

I am Paul Oshiro, testifying on behalf of Alexander & Baldwin, Inc. (A&B) and Matson Navigation Company, Inc. (a subsidiary of A&B) on HB 865, "A BILL FOR AN ACT RELATING TO INSPECTION FEES." We sincerely appreciate the opportunity to provide comments on this bill.

In 2008, amendments were enacted to broaden the scope of the invasive species user fee from one that assessed fees only on freight brought into Hawaii by maritime containers to one that assessed fees on all modes by which commercial freight is brought into the State, including air and maritime containerized and non-containerized freight. We support the present broad based application of the invasive species user fee that requires all transporters to pay for these inspection services through the payment of this fee.

Matson has dedicated a considerable amount of time, effort, and expense to implement the assessment, collection, and disbursement of this new fee by the effective date of August 1, 2008. We were successful in starting up the collection of this new fee by the effective date and have since been diligently proceeding with its implementation.

This bill increases the amount of the invasive species user fee to provide additional funding for the Hawaii Biosecurity Program. We understand that this program consists of several components that are necessary to comprehensively control the infestation of invasive species in the State of Hawaii. In that this multi-faceted program also includes several initiatives outside of port of entry inspections, your continued consideration to provide a broad based source of funding for this program, in addition to funds derived from the invasive species user fee, would be greatly appreciated.

My name is Alicia Maluafiti, Executive Director of the Hawaii Crop Improvement Association, a nonprofit trade association representing the seed industry in Hawaii. HCIA strongly supports HB 865.

HCIA believes that HB 865 is an important and necessary initiative to address the cutbacks to the Dept. of Agriculture as a result of Hawaii's fiscal crisis and the department's reliance on the general fund to support the ag inspector positions. The agricultural industry including the seed industry's whose shipments require inspection by the HDOA risk their long term economic viability when they cannot get their products through the inspection process in a timely manner.

We support many of the these legislative efforts including fee increases to restore the Dept. of Agriculture positions, minimize the adverse impact of the budget crisis on their department, and ensure the HDOA's ability to support, promote and enhance Hawaii's agricultural industry. However, we hope that the legislature and the HDOA continue to balance this fiscal responsibility with other stakeholders that share a commitment to supporting the inspection, quarantine and eradication of invasive species coming into the state.

Supporting the Intent of H.B. 865 Relating to Inspection Fees

The Nature Conservancy supports the intent of H.B. 865 proposing to increase the invasive species cargo inspection fee from 50¢ to \$1.00 for every 1,000 lbs. of cargo. However, we are concerned about both the perception and effect on Hawai'i businesses and consumers by doubling the fee at this time and in this economy.

Invasive weeds, insects, diseases, snakes, and other pests are one of the greatest threats to Hawaii's economy, agriculture, natural environment, and the health and lifestyle of its people. The HDOA has developed a multi-faceted Biosecurity Plan to enhance its invasive species prevention efforts with more inspectors, more efficient and effective inspection services, improved inspection facilities, and agreements with importers and producers for improved sanitary protocols before items are shipped to Hawai'i. The Legislature's ongoing policy and financial support of the Biosecurity Plan has been essential to its implementation.

The Hawai'i Department of Agriculture (HDOA) has indicated that current cargo fee collections of approximately \$3.1 million annually are insufficient to cover the necessary inspection requirements at Hawaii's air and sea ports to prevent pests from entering the state. This shortfall is exacerbated by reductions in the department's general fund allocation.

The Nature Conservancy strongly supports reasonable service fees, and meaningful fines for failure to pay such fees, for the HDOA's invasive species inspection, quarantine and eradication activities. This is an appropriate way to support the critical functions of the HDOA to protect our economy, environment, health, and lifestyle from the introduction and spread of pests and diseases. However, we acknowledge that doubling the fees at this time may be a difficult burden for Hawaii's businesses and residents.

Aloha Committee Chair and Committee Members,

I am an organic farmer on the North Shore of Oahu and President of the Hawaii Center for Organic Farming. Please accept my testimony on the subject Bills.

In the case of SB 866: Related to the Registration of Beekeepers. I am opposed to this Bill as written because it appears to have no real purpose other than a bureaucratic registration process. I am a beekeeper; two years ago I had 10 hives; I am now down to 2 hives due to varroa mite. Our Department of Agriculture has been deficient in both their measures for preventing invasive species as well as their rapid response to new infestations. This Bill could have enormous support to our beekeepers if "registration" was part of an overall bee industry invasive species prevention AND treatment program.

In the case of HB 284: Related to Income Tax Exclusions for Small Farmers. I am a small farmer who will benefit by this Bill; however it is far too generous and too inclusive. As written with the \$500,000 limit, this Bill will provide tax exclusions to 97% of our farms including all fake farms, all backyard gardeners and hobbyists. To conform to the State's 2050 Sustainability Plan, supportive legislation must focus on those real farms that grow "local food for local consumption". I recommend this Bill be amended to: 1) restrict tax exemptions to only those farms producing foods for our own local markets, NOT exports; 2) reduce the ceiling to \$100,000 to better focus on "real" small farms and; 3) add a floor of \$25,000 to eliminate fake farms and home gardens.

In the case of HB 286: Related to Excise Tax Exclusions on the Sale of Agricultural Products. I am opposed to this Bill as written because it will exempt ALL farms in the State from the Excise Tax. By our existing Excise Tax Code, farmers are "producers" and already only pay .5% vs 4% (4.5% on Oahu). Any exclusion from our Excise Tax should only be directed to those small farms that grow "local food for local consumption". We should not be exempting large farms or those that produce for export or those that produce non-food items such as GMO corn seed.

In the case of HB 865: Increases the Inspection Fee. Presently, our public monies are being used to subsidize the importation of food which undermines competition of our local farmers. This Bill should be amended to task the Hawaii Department of Agriculture (HDoA) to identify ALL of its budgeted expenses associated with this inspection effort and further amended so that the fee covers and replaces ALL of these budgeted costs.
