Department's Position:	The Department supports the proposed SD1 for HB 945 HD 2 relating to		
	Education. The draft proposes to delay the implementation of Act 167 by		
	two years.		
	The Department is committed to meeting the requirements of Act 167 for		
	increased instructional days and time. However due to the new economic		
	realities for the State, the Department will face significant fiscal limitations.		
	With reductions to the Department's budget of \$55 million per year in the		
	House draft of the biennial state budget and further anticipated reductions		
	as a result of another forecast from the Council on Revenues and the		
	impact of the earthquake and tsunami in Japan, it is doubtful that the		
	Department will be appropriated the additional funding that Act 167 will		
	require.		
	The additional work time required by Act 167 will require additional		
	funding for either compensation for more time spent in instruction or for		
	additional teachers to provide additional instruction during a lengthened		
	school day and year.		
	The Department will work with the parties set forth in paragraph (e) on		
	page 2 to report to the Legislature progress made toward implementing		
	the requirements of Act 167.

## **RELATING TO EDUCATION**

House Bill No. 945, H.D. 2, Proposed S.D. 1, postpones implementation of Act 167, SLH 2010, from School Year 2011-12 to School Year 2014-15. Act 167 mandates minimum instructional times in public schools starting in School Year 2011-12.

The Department of Budget and Finance strongly supports the Proposed S.D. 1.

Collective bargaining is currently underway between the State, the Hawaii State Teachers Association, United Public Workers, and Hawaii Government Employees Association. One of the issues affecting negotiations regarding employees of the Department of Education is the impact of implementation of Act 167.

As you are aware, labor savings is currently factored into the Administration's approach to balancing the general fund financial plan. In order to achieve those savings, some form of relief from Act 167 is necessary because it is unrealistic to expect that labor savings can be negotiated while at the same time increasing work requirements.

Given the State's fiscal condition, we simply do not have the means to implement Act 167 at the present time.

We are in OPPOSITION to the current draft of HB945, which authorizes a decrease of instructional time for children in multi-track schools of up to 10%. We support an exemption to the 180 days if the instructional time stated in Act 167 is still required.

There are many other states with multi-track schools and they do not allow a decrease in instructional time from what is legislated. They have found a way to fit in 180 days or lengthened the school day. Many parents at Hawaii's multi-track schools want 180 days. They have been assured the length of the school day will be increased to make up the instructional time.

Since most of us are in agreement that 171 days is a viable exception we must begin to look at how to achieve the instructional time. The Complex Area Superintendent has testified that the schools CAN meet the instructional time for the 2011-2013 school years (Phase One). This is an increase for multi-track students of 16 minutes for elementary students and 17 minutes for secondary students:

Instructional Time	Traditional-180 days	Track-171 days
Elementary School	5 hours 5 minutes a day	5 hours 21 minutes a day
Secondary School	5 hours 30 minutes a day	5 hours 47 minutes a day

School Day with Lunch, Recess, and Passing time (shorter on teacher collaboration days)				
Elementary School	6 hours 30 minutes a day	8:00am-2:30pm		
Secondary School	7 hours 15 minutes a day	7:45am-3:00pm		

These hours are comparable to private schools around the island and public schools on the mainland.

Phase Two of Act 167 will be a new HSTA contract with a new Board of Education, experience with Race to the Top funding, and two additional years with increased instructional time. In 2013, we should reevaluate Act 167, and discuss any necessary modifications at that time.

As we look at Race to the Top, one of the goals is to increase instructional time to improve educational outcome in students (SB1171). We can not, in the same session, decrease instructional time for another set of students.
