

Our reason for writing today is to express our strong support for the HCR 147 urging the United States Congress to approve the United States-Korea Free Trade Agreement submitted before the House Committee on International Affairs.

As you are well aware, Korea has risen from war-ravaged poverty to become the 11th largest economy in the world. Korea is the 7th largest trading partner of the United States with over \$80 billion in annual trade volume, the 6th largest market for U.S. agricultural products and the 3rd largest destination for U.S. foreign direct investment in the Asia Pacific region. Under these circumstances, we believe the KORUS FTA is a good deal and is expected to give both the United States and Korea tremendous mutual benefits, with virtually every U.S state having a stake in the expanded bilateral trade and investment relationship.
