Purpose of Resolution:

Requesting each school within a regional administrative district where taro farms are located to serve poi or other taro products, and requesting the director of agriculture education program to arrange for work, volunteer, or

study opportunities on taro farms.

Department's Position:

The Department of Education (DOE) believes it would not be able to honor the request in this resolution. DOE understands there are taro farms in every administrative district in the state. Most farms are not certified and do not sell taro or taro products directly to consumers. DOE questions whether there is an adequate supply of taro and taro products, produced from Hawaii-grown taro, to have taro or taro products on every school menu weekly. Finally, restricting procurement of taro and taro products only to farmers in the administrative district in which the school is located would not be an acceptable procurement practice, because of the lack of competition.

Therefore, DOE cannot support the section of the proposed resolution to serve poi or other taro products in a regional administrative district where taro farms are located

Aloha Honorable Committee members,

These two resolution bills (HCR 177/HR153) are a great step in the right direction for our state. For too long, our local schools have had to serve menus defined and created at the federal level and geared to mainland tastes and diets.

These resolutions support local food self-sufficiency and providing healthy culturally relevent foods. Taro is both hypo-allergenic (students with wheat and rice gluten allergies can eat it) but is also one of the most complex carbohydrate starches you can eat (better and safer for diabetics).

As an culturally indigenous food, the inclusion of taro, poi and lu'au makes sense for Hawaii We need to be sure our children are not growing up believing that the cooked spinach they are told is lu'au in today's schools is the real deal or an better alternative.

These two resolutions also encourage schools to serve taro, lu'au and poi in meals that come direct from the taro farmers in their districts which means significantly reduced fuel miles for the food in our schools (the average canned corn and hot dog lunch travels 3,500 miles not to mention the fuel expended in processing and packaging). Local food sourcing expanded markets for taro farmers and dollars stay in our communities longer.

The more students we can bring into the lo'i, the more they will have another reason to learn more about, and stay connected, to the place they live.
