HOUSE CONCURRENT RESOLUTION NO. 83
REQUESTING THE DEPARTMENT OF AGRICULTURE TO CONDUCT A STUDY LAYING THE GROUNDWORK FOR IMPLEMENTATION OF THE AGRICULTURE WATER DEVELOPMENT PROGRAM, INCLUDING PERFORMING A STATEWIDE WATER DEVELOPMENT STUDY.

Chairpersons Tsuji and Nishimoto, and Members of the Committees:

Thank you for the opportunity to testify on House Concurrent Resolution No. 83. The purpose of this resolution is to lay the groundwork for implementation of the agriculture water development program, including performing a statewide water development study. The Department respects the intent of this bill, however, offers that this study is unnecessary as a majority of the issues identified in this bill are currently included in the ongoing Agricultural Water Use and Development Plan (AWUDP) or identified in the Commission on Water Resource Management's *Statewide Framework for Updating the Hawaii Water Plan* (2000) for future study in the AWUDP.

We also recognize that this resolution is very similar to House Bill 1228. HB 1228 recognized that a study of this magnitude would require significant funds to complete it in that it also established the water development study special fund. HCR 83 maintains all of the requirements of study from HB 1228, without any recognition of the massive effort involved to perform the work. We respectfully stress that we believe efforts should be made to complete the AWUDP before additional studies are proposed as we believe the AWUDP should be the



principle document for Hawaii's agricultural water needs. We estimate that pending appropriate funding, the completion of the AWUDP could be done in approximately five years.

The Department of Agriculture has been statutorily mandated to develop the AWUDP. In recognition of this need, the U.S. Department of the Interior, Bureau of Reclamation (BOR) has been providing matching federal funds to assist in the research necessary to continue the study. We have been informed by the BOR that another request has been submitted in their current budget. To complete this plan, in-depth studies of irrigation systems throughout the state are being conducted. As the State currently has no long-term agricultural water use plan, it is unclear how much of the abandoned sugar cane and pineapple plantation land is suitable for diversified agriculture and what the current and future water demands may be. Additionally, capital improvement projects for the aging irrigation systems need to be identified so the State can take proactive measures to prevent a catastrophic failure of an irrigation system.

The AWUDP identifies projected water uses and demand for various crops which will be instrumental in long-term planning of the systems. It will also eventually inventory all known systems identified in the first phase of the plan as well as other systems that have come to our attention, and create a capital improvement plan as needed. Work will additionally include a historic description of the original infrastructure, existing conditions, assessment of the current concerns and needs, proposed maintenance improvements, estimated costs, identification of each system's sources and water use requirements for Hawaii's expanding diversified agriculture industry, and development of long-term water use projections. The study will potentially identify which systems can be restored versus which systems may be abandoned as well as possible water source planning and development.

The Commission's *Statewide Framework for Updating the Hawaii Water Plan* (2000) recommends additional plan elements for the AWUDP. As such, the State Water Code and Statewide Framework for Updating the Hawaii Water Plan already includes and addresses the study elements proposed in House Concurrent Resolution 83.
