


 The Honorable Tom Brower, Chair, House Committee on Tourism and Committee Members:

My name is Derek S. K. Kawakami, and I submit this testimony in support of H.C.R. 8 and H.R. 10 in my capacity as President of the Hawai'i State Association of Counties (HSAC). 

 The Hawai'i State Association of Counties is in support of H.C.R. 8 and H.R. 10, as both resolutions were included in the 2011 Hawai'i State Association of Counties Legislative Package. The purpose of Act 185, Session Laws of Hawai'i 1990, was to provide a more equitable method of sharing state revenues with the counties rather than continuing with the system existing at the time whereby the counties requested financial assistance through "grants in aid" from the State. The counties' share of the transient accommodations tax (TAT) also provides a stable revenue source and enables counties to properly plan when balancing their annual budgets. Maintaining the current allocation of the TAT would assist counties in continuing to provide essential government services to both visitors and residents alike. Losing the current allocation of the TAT would require the counties to consider significantly raising property taxes, increasing fees, and cutting programs and services that benefit both residents and visitors.

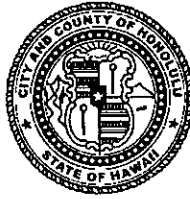

Chair Brower and members of the House Committee on Tourism, Mayor Peter Carlisle submits the following testimony in support of HCR 8 and HR 10.

The purpose of these resolutions is to urge the Governor to preserve the counties' share of the Transient Accommodations Tax (TAT).

The Transient Accommodations Tax (TAT) is an integral and essential part of the counties' base budgets. The TAT was created as a more equitable method of sharing state revenues with the counties in recognition of the greater impact of the visitor industry on county services such as police, fire protection, parks, beaches, water, roads, sewage systems and other tourism-related infrastructure. The legislature also noted that the distribution of the TAT to the counties was meant to provide a stable and continuing source of revenue for the counties.

The City and County receives a 44.1% share of the TAT allocated to the counties which amounts to approximately \$45 million dollars for the City and County. These funds provide services such as police, fire, lifeguards for visitors as well as the infrastructure for trash disposal, water and sewer services necessary to support them. Without the current level of TAT funding, the counties would find it difficult to maintain services and infrastructures without shifting the burden to property owners.

For this reason, we strongly support the adoption of HCR 8 and HR 10 and thank you for this opportunity to testify.
