Comments:

The resolutions HR258 and HCR293 call for the removal of " Treaty of Annexation" from the object held in the hand of President McKinley in the bronze statue in front of McKinley High School.

The resolution asserts that there never was a Treaty of Annexation.

But of course there was such a treaty. In fact, there were two treaties.

The first treaty was offered by the Provisional Government of Hawaii in January 1893 but later withdrawn from the U.S. Senate by President Grover Cleveland when Cleveland took office in March 1893.

The second treaty was offered by the Republic of Hawaii in 1897, when William McKinley was President. At first it was rejected by the U.S. Senate. However, upon further consideration and in light of world events, it was then accepted by joint resolution of the entire Congress in 1898. The vote was 42-21 in the Senate (exactly 2/3) and by 209-91 in the House (more than 2/3).

There are some Hawaiian sovereignty activists who like to say there never was a Treaty of Annexation. That's because they dislike the way the United States chose to exercise its sovereignty to accept the treaty. The activists claim that the U.S. can only ratify a treaty by a 2/3 vote of the Senate. But how a nation chooses to ratify a treaty is entirely up to that nation to decide for itself. The U.S. chose to ratify the treaty by means of a joint resolution, just as had been done 50 years previously in the annexation of Texas (which also was an independent nation at the time it was annexed). It is not for the Hawaiian activists to choose the method whereby the U.S. chooses to exercise its sovereignty to accept and ratify a treaty offered by another nation. That is a matter for the U.S. alone to decide. Those members of the U.S. Senate who opposed the treaty could have filed a complaint with the U.S. Supreme Court, but chose not to do so and acquiesced in the use of the joint resolution. It is now settled law; governed by the principles of "stare decisis" and "laches."

But even the Hawaiian sovereignty activists must acknowledge that the Republic of Hawaii did indeed offer a Treaty of Annexation to President McKinley, and that he accepted it and submitted it first to the Senate and later to both the House and Senate.

So even the sovereignty activists are forced to acknowledge that the McKinley statue is correct, at least insofar as it shows President McKinley holding a document entitled "Treaty of Annexation" which was offered to him by the Republic of Hawaii. Hawaii held the Treaty of Annexation out to President McKinley, and he accepted it into his hand, just as the statue portrays.

This legislature can make history by the laws it enacts, but this legislature cannot rewrite history. Please do not succumb to the demands of the Hawaiian sovereignty history-twisters.

## **Testimony in Support of HCR 293**

Aloha Rep. Hanohano and members of the Committee on Hawaiian Affairs,

Mahalo for this opportunity to provide testimony in support of HCR 293.

My name is Lynette Cruz. I am an assistant professor of anthropology at Hawaii Pacific University. I am also the president of Ka Lei Maile Alii Hawaiian Civic Club.

As a teacher, I have concerns when I encounter local high school students who are now my students who have not learned about Hawaiian history, about the overthrow of Queen Liliuokalani, or about the fact that there was never a treaty of annexation between the Hawaiian Kingdom and the United States. Further, I find that most students, from Hawaii or the U.S., have no idea how one country can become part of another. Unlike European students who seem to have a clearer grasp of the political and military history of Europe, Asia, and the rest of the world including Hawaii, American students seem to know little. I've often wondered why that is. Sometimes it appears that public school students in particular have been subjected to the 'dumbing down' effect, where educational programs stress training and service over critical thinking.

Most Hawaii students today know about William McKinley, 25<sup>th</sup> president of the United States. They know about him because there is a school in Hawaii named after him. In many ways, he is seen as a hero. In contrast, very few students know anything at all about Grover Cleveland, friend of Queen Liliuokalani, Hawaii's last reigning monarch. In Hawaii, President Cleveland is relatively invisible, even though he acknowledged the right of the Hawaiian people to maintain its independent status and resist annexation to the United States. He withdrew from the Congress the first treaty of annexation. Further, it was Cleveland who dispatched Georgia Congressman James Blount to Hawaii to investigate the circumstances surrounding the overthrow (the Blount Report). It might be fair to say that schools, buildings, streets in Hawaii that have been named after imported heroes serve the purpose of reinforcing a particular history of these islands and the role played by those who did us all a disservice and propagated misinformation. Let us not allow this disservice to continue.

As the president of Ka Lei Maile Alii Hawaiian Civic Club, I speak on behalf of our club in support of HCR 293. In 2009, our club introduced a resolution very similar to HCR 293 at the annual Association of Hawaiian Civic Clubs Convention on Maui. It passed

unanimously. It was our feeling that the delegates in convention appreciated the opportunity to learn about our history, as some had no inkling of our colorful past, and to support small steps to correct misinformation, especially within the public school system. Their support was evident in their vote. I ask that you also vote in support of this idea. I recommend this be done in two ways: 1) by making a formal statement to that effect, and 2) by creating a fund to pay for the removal of the document called 'Treaty of Annexation' through solicitation of voluntary contributions from the general public. I would request, further, that Ka Lei Maile Alii Hawaiian Civic Club be given the responsibility to assess costs of the repair, raise funds to cover costs, and oversee the completion of this project.

Our civic club realizes that the state may not so easily commit to allocating funds to such a project, given that other issues, including the compelling issue of furloughs in the public school system, have not yet been addressed. This is a small project, relatively speaking, but one that may well start the process of reconciling the various histories being taught about this place we call home. Mahalo for your consideration.

Chair Hanohano and Vice Chair Le and members of the House Committee on Hawaiian Affairs:

Aloha, I am Leon Kaulahao Siu, here representing the Hawaiian Kingdom, a nation in continuity, to **support** HR 258 and HCR 293. Our purpose is not to interfere with, nor to participate in the operations of this puppet government, the State of Hawaii. Our purpose is to clarify the historical context for the action being called for by these resolutions. Like others gathered today, our interest here is in setting the record straight.

Contrary to the 100-pus years of propaganda and indoctrination, President William McKinley was no friend to the people of Hawaii. We now understand that the so-called annexation of Hawaii to the US was a fraud perpetrated by US President McKinley and his administration in collusion with the traitors Dole, Thurston, Castle, Dillingham and the like.

The renaming of Honolulu High School and the erection of a statue in honor of William McKinley stands as an affront to the Hawaiian people. It is the statue of a callous conqueror, not a friend. The eight-ton bronze statue of President McKinley was commissioned for \$8,000. Completed in New York, the statue was shipped to Honolulu and dedicated on February 23, 1911 by Sanford B. Dole.

How painful an event that must have been for our kupuna who had just a few years earlier almost unanimously signed the Ku'e Petitions that successfully stopped the US Senate from ratifying the Treaty of Annexation to the United States. How outraged and betrayed they must have felt to see in the statue's hand, a Treaty of Annexation! ... a completely fabricated image of a document that doesn't exist ... a celebrated criminal act.

So here we are 100 years and one month later, and the State of Hawaii has the opportunity to make at least this one minor correction to the false narrative of annexation. We ask that you pass HR 258 and HCR 293.

Attached is a brief history of the school that was founded in the Hawaiian Kingdom in 1865 as the Fort Street English Day School.

McKinley High School was officially established in 1865, as the Fort Street English Day School by Maurice B. Beckwith. In November 1869, the English Day School moved from the basement of the old Fort Street Church to a new stone building on the corner of Fort and School Streets. The Fort Street School later moved to the Princess Ruth's Palace in 1895 and was renamed the Honolulu High School.

In 1907, Honolulu High School moved to the corner of Beretania and Victoria Streets. The school's name was then changed to President William McKinley High School, after President William McKinley, whose influence helped to bring about the annexation of the Hawaiian Islands to the United States.

A statue of President McKinley was commissioned for \$8,000. Completed in New York, the bronze eight-ton statue was shipped to Honolulu and dedicated on February 23, 1911.

With growing enrollment, a new and bigger school was necessary. In 1921, the present site on King Street was acquired through territorial condemnation. In 1923, the school was moved from the Beretania Victoria site to its present location. McKinley High School is proud to be listed on both State and National Register of Historical Places.
