Good afternoon. My name is Amy Monk and I thank you for hearing this bill and for allowing me to present testimony today, in strong support of HR 9— "Recognizing the need to reach out to Hawaii women and engage them in the political process."

First of all, I want to thank Reps. Linda Ichiyama and Marilyn Lee, members of the Women's Legislative Caucus and all of you who have co-sponsored and support this resolution.

As many of you know, the Patsy T. Mink PAC was founded in 2003 by former Lt. Governor and now Congresswoman Mazie Hirono. Our mission is to improve the lives of Hawaii's women and their families by supporting and electing pro-choice Democratic women with demonstrated commitment to the values of Patsy T. Mink. We are patterned after Emily's List, who helped Congresswoman Mink who, incidentally, was the first woman of color and first Asian Pacific American woman elected to Congress.

In the four election cycles since we were founded, we are pleased to report that we have helped elect and re-elect 13 women to the State Legislature, including Colleen Hanabusa who was elected to Congress, Maile Shimabukuro who's been appointed to the Senate from the House, and Hermina Morita, the new chair of the Public Utilities Commission.

Last year the Patsy T. Mink PAC sought to do more to address the needs and concerns of Hawaii's women. Being in the political arena, we are aware that political polls are more often than not focused on the older women and the women who are registered to vote.

We wanted to hear and address concerns from <u>all</u> women, including younger women and those who are not registered to vote.

It is our belief that the younger women are, and are raising, our future leaders.

But, we had no data or facts to back up our beliefs regarding Hawaii's younger women. What are their issues? Their concerns? Are they engaged in the political process? Why and why not? We decided to put our money where our mouth is.

The Patsy T. Mink PAC contracted QMark Research to conduct a quantitative study of women ages 18-44. A total of 249 telephone interviews and 422 internet surveys were completed from mid-July to mid-August of 2010.

We learned that a significant number – 77 percent – said they are pro-choice and consider choice an important issue. Yet, over half of them said they could support a candidate that did not agree with their position if they were comfortable with the candidate's position on other important issues.

The most important issue that women want their legislators to work on is the high cost of living, followed by higher quality of education for their children. Nearly half of the respondents said conditions in Hawaii – and the nation – need an overhaul.

A quarter of the women surveyed had reached out and contacted a local politician, but out of those who sought help, a quarter of them never received a response.

The other three quarters of the women who had never contacted a local elected official said they believed their concerns might not be taken seriously.

Clearly, this is sobering news. Our survey indicates that young women feel disenfranchised and believe their voices are not heard.

At our focus groups and through our survey, we learned that young women would like to become involved in public policy but need assistance and education as to how to start.

Because the Patsy T. Mink PAC believes women are an important and significant force in Hawaii, and we want our political leaders to be aware of and address their concerns, we would like to respectfully suggest a first step to respond to them.

Actually, this suggestion comes directly from the young women in our focus groups. Because they fear that they won't be taken seriously by their political leaders, they asked if our political leaders could hold an organizational meeting just for them to talk to each other about what concerns them – and for our political leaders to just listen to them. The Patsy T. Mink PAC believes such a meeting would be a most valuable first step toward encouraging Hawaii's young women to get involved in the public policy arena. Moreover, we would be pleased to assist you in any appropriate way in this endeavor.

In closing, again, I wish to say mahalo to all of you for your interest in Hawaii's women – and for your continued leadership in helping them and their families.

Planned Parenthood of Hawaii (PPHI) strongly supports HR 9, which encourages women to become more civically engaged and asks the Legislature to be more inclusive of women in leadership roles. Because female voices are necessary for balanced decision making, PPHI supports this resolution.

In 2010 the Patsy T. Mink Political Action Committee released study results that indicated the overwhelming majority, nearly 72%, of young women in Hawaii feel estranged from the political process. What is more concerning is that only 4% of the women surveyed felt that their participation in the political process would produce any meaningful result.

We see a lack of female leadership within the State Legislature. Only two members of the 10 person House leadership team are women, compared with the Senate's nine member leadership team, four of whom are women. Out of 20 standing committees, the House has just five female Committee Chairs. The Hawaii Senate has designated 14 standing committees, five of which are chaired by women.

Yet, the State Legislature hears numerous issues every session that directly impact women's lives. This session, bills were introduced that extended protections to victims of sexual and domestic violence, improved health care for sexual assault victims, created greater access to justice for victims of child sexual abuse and sexual assault, improved the treatment of incarcerated women, funded perinatal care for women with substance abuse issues, continued funding for cancer screenings for women over the age of 45, and sought to do something about Hawaii's high teen pregnancy rate. Many of these important bills have failed to progress through the legislative process. Finally, the state's budget crisis has had a serious impact on women as many of the social services that provide Hawaii's women and children with basic health, safety and welfare received dramatic cuts.

At PPHI, we have set of twelve core beliefs that help inform our mission and our every day work. Among these strongly held beliefs is that women deserve an equal place at life's table and should be respected as moral decision makers. Therefore, we respectfully ask this committee to pass HR 9. Thank you.

The Hawai'i State Democratic Women's Caucus is a catalyst for progressive, social, economic, and political change through action on critical issues facing Hawai'i's women and girls. It is because of this mission, the Women's Caucus strongly supports this measure.

In 2010 the Patsy T. Mink Political Action Committee released study results that indicated the overwhelming majority, nearly 72%, of young women in Hawai'i feel estranged from the political process; even more concerning, only 4% of the women surveyed felt that their participation in the political process would produce any meaningful result.

In order to reverse these perceptions, more women must be in visible leadership positions within the State Legislature. Only two members of the 10 person House leadership team are women, compared with the Senate's nine member leadership team, four of whom are women. Out of 20 standing committees, the House has just five female Committee Chairs. The Hawai'i Senate has designated 14 standing committees, five of which are chaired by women.

Yet, the State Legislature hears numerous issues every session that directly impact women's lives. This session, bills were introduced that:

- improved health care for sexual assault victims,
- created greater access to justice for victims of child sexual abuse and sexual assault, improved the treatment of incarcerated women,

Sadly, many of these important bills have failed to progress through the legislative process.

Finally, the state's budget crisis has had a serious impact on women as many of the social services that provide Hawai'i's women and children with basic health, safety and welfare receive dramatic cuts.

We feel strongly that that more effort should be made to engage women in a process that affects them so profoundly. We encourage leaders in the legislature to examine ways in which they could encourage that engagement and to start by including more women in leadership roles.

We ask that you pass HR 9. Thank you for this opportunity to provide testimony.


The women were articulate about not seeing their government as addressing issues that mattered to them and not seeing themselves as having any power to change that.
