## State Homeless Programs

The Homeless Programs Office is Located in the Department of Human Services, Benefit, Employment and Support Services Division

Mission: Provide homeless and at-risk homeless families and individuals opportunities to stabilize their housing, health, employment and social issues to achieve long term stability and economic independence.

Function: Maximize State, Federal and other resources for programs that target the homeless and at-risk homeless, utilizing national best practices to develop programs in collaboration with community-driven strategies.

## Planning Partners

- County Continua of Care Community based planning groups that develop strategies for mitigating homelessness in each county
  - Kauai Community Alliance
  - Maul Homeless Alliance
  - Partners in Care (Oahu)
  - Community Alliance Partners (Hawaii)
- Hawaii State Interagency Council on Homelessness – Representatives from State Depts., County governments, County Continuum of Care chairpersons, and provider agencies charged with developing a State plan to end homelessness

## Homeless Annual Funding

- State Government \$14 million annually
- TANF \$4.5 million annually
- Federal Housing and Urban Development (HUD) – Approximately \$16 million total for the City and County of Honolulu and for the State on behalf of the three rural counties. State share: \$2.5 million.

## State-Funded Homeless Programs

(Programs Available Statewide)

- Shelter Program Provides emergency and transitional shelter & services
- Outreach Program Care-a-Van outreach to unsheltered homeless at beaches, parks, and other locales to deal with issues of public health and safety
- Grant Program Provides homeless prevention through grants and loans
- Community Reintegration Program Provides temporary housing for exiting offenders who would otherwise become homeless

- Additional shelter beds 766 beds (emergency shelters)

Maui:\ 120 units plus 127 beds

# TANF-Funded Housing Programs

 Housing Placement Program – Agencies cultivate landlords to make affordable rental units available to credit-risky homeless and homeless at-risk persons/families who are case managed to be responsible renters. The program also provides initial rental and/or deposit assistance plus ongoing client visitation and mentoring

\*\*841 families (3,465 individuals) were placed in permanent housing in FY 2010, through this program

 Some TANF funds are also used to supplement funding for the Homeless Shelter Programs

## Federal HUD-Funded Programs

- Emergency Shelter Grant Annual appropriation providing supplementary operating funds for emergency shelters
- Housing Opportunities for Persons with AIDS Annual appropriation to assist with housing needs of the target population
- Shelter Plus Care Rental assistance plus services program for homeless persons with disabilities
- Supportive Housing Program Targeted funding for programs to help the homeless develop selfsufficiency

# HUD - Homelessness Prevention and Rapid Rehousing (ARRA)

The rural Counties were awarded \$2,166,888 in HPRP funding and the City and County of Honolulu received an award of \$4,016,074.


The funding was for a period of no more than three years, but the funds will be exhausted by the end of 2011. To date, the impact has been substantial in keeping the homeless-at-risk housed and rapidly re-housing those who become homeless.

- Hawaii's shelters served 7,649 people at 36 shelter sites (2559 were children)
- Hawaii's eight outreach agencies served 7,997 unsheltered homeless persons (697 were children)
- The State grant program provided homeless prevention

## Statewide Point in Time Count

- Date conducted: January 25, 2010
- Sheltered Count: 3,535 people
  2,797 on Oahu (79%)
- Unsheltered Count: 2,299 people
   1,374 on Oahu (60%)
- Chronically Homeless: 705 persons 30% of the unsheltered homeless

(The latest count was completed in Jan. 2011, however the results of that count will not be available until April 2011)

## Homeless Demographics

- Residency: 61% of the sheltered and 67% of the unsheltered have been Hawaii residents for 10 or more years.
- Veteran Status: 10% of the sheltered and 12 % of the unsheltered are veterans.
- Ethnicity: Sheltered 29% Hawaiian or part Hawaiian, 26 % Other Pacific Islander and 21% Caucasian.

  Unsheltered 46% Caucasian and 27% Hawaiian or part Hawaiian.
- Employment: 28% of the sheltered and 12% of the unsheltered are employed.
- Education: 70% of the sheltered had a high school diploma through college.
   75% of the unsheltered had a high school diploma through college.

## Most Needy Priced Out of Homes

### Elderly, Disabled & Mentally III

 A disabled person living on Supplemental Security Income, (SSI - \$603/mo) and renting in Hawaii would have to spend:

Honolulu: **147.3**% of benefits
Non Metropolitan Areas: **131.5**% of benefits

- Housing First is a shift in philosophy from a person needing to CHANGE to merit a home
   TO "everyone deserves a place to live"
- Permanent Supportive Housing (PSH) is Housing PLUS Services

# Permanent Supportive Housing Saves Lives and Money

- P\$H is a solution to chronic homelessness which poses the greatest health risk and impediment to recovery
- Regular home visits by case managers help to ensure appropriate behavior and long-term residency
- PSH is a cost effective solution saving community costs in emergency hospital visits, incarceration, public facility degradation, and failing our neediest.

- 1. The current inventory of housing stock in Hawaii, the current and future demand for housing in the various categories of income range, age range, family type;
- How many projects are currently underway, could be underway if more funds were made available in the Rental Housing Trust Fund (RHTF) and the Dwelling Unit Revolving Fund (DURF); and
- 3. The timeline for these units to be available for those who do not currently have homes of their own including the number, type, location, etc. of affordable rental housing and for sale housing units.


### OVERVIEW OF HOUSING SUPPLY AND DEMAND

# **Housing Supply**

According to the 2006 Hawaii Housing Policy Study, there were an estimated **475,863 total housing units** in the State of Hawaii in 2006. As shown in the chart, below, single family homes comprise the majority of housing units (57.2%), followed by condominium (27.4%), apartment (10.8%), and military and other housing. A breakdown of the housing units by county and housing type is shown in Appendix **A**.



An **inventory of state and county-assisted rental housing** by county and type of unit (e.g., elderly, family, public housing, special needs) is provided in Appendix **B** and may be viewed on the Hawaii Housing Finance and Development Corporation's website at <a href="http://hawaii.gov/dbedt/hhfdc/resources/Affordable-Housing-Inventory.pdf">http://hawaii.gov/dbedt/hhfdc/resources/Affordable-Housing-Inventory.pdf</a>. About 69 percent of the nearly 21,000 permanent rental housing units are for families; approximately 44 percent are owned by state or county government agencies.

A directory of **HUD** assisted rental housing projects is attached at Appendix **C**. Of the total of 109 Hawaii rental projects in this directory, 91 projects have HUD contract expiration dates within the next 5 years. Most of these 91 projects are owned by government agencies or non-profit corporations with affordable housing missions. However, 14 projects comprising a total of 1,098 units are owned by for-profit entities and could exit from the affordable rental housing inventory over the next 5 years.

### Housing Demand

The number of families on the public housing waiting list is an indicator of the need for affordable rental housing opportunities. As reported in the State of Hawaii Consolidated Plan for Program Years 2010 – 2014, there were **8,834 households on the waiting list for federal low-rent public housing statewide as of January 1, 2009**.

The number of families on the Section 8 Housing Choice Voucher waiting lists is also an indicator of the need for affordable rental housing opportunities. The State and each of the four counties administer Section 8 tenant-based assistance programs and maintain waiting lists for the program. In 2009, approximately 17,020 households were on the Section 8 waiting lists statewide. (Households on the wait list for Section 8 tenant-based assistance may also be on the public housing wait list.) Demographic information for households on the public housing and Section 8 waiting lists are shown in Appendix D.

Privately-owned rental housing projects that were assisted with low-income housing tax credit or RHTF financing have a weighted average vacancy rate of 2.4 percent. There are approximately **7,217 households on the waiting lists**, with an average wait time of 1-3 years.

Estimates of housing need by 2015 by county and income group are shown in the table on the following page. The estimates are based on data from the 2006 Hawaii Housing Policy Study prepared by SMS Research for HHFDC and other state and county housing agencies. (HHFDC, in conjunction with the Department of Hawaiian Home Lands, Department of Human Services – BESSD, and the Counties of Honolulu, Hawaii, Kauai, and Maui, recently commissioned a new study, which should be completed in September 2011.)

- Approximately 17,400 rental units for households with incomes at 80% and below the HUD median income are projected to be needed by 2015.
- An additional **6,800 for-sale units** for households with incomes between 80% and 140% of the HUD area median are projected to be needed by 2015.

#### HHFDC RESOURCES FOR HOUSING DEVELOPMENT

HHFDC's mission is "to increase and preserve the supply of workforce or affordable housing statewide by providing leadership, tools, and resources to facilitate housing development." Our major development tools are the provision of land and the Chapter 201H development program which provides for expedited processing of land use/zoning requests and flexibility in the design of housing projects.

Major financing tools include interim construction loans, tax credits, and equity gap loans.

The **Rental Housing Trust Fund** (RHTF) is an important financing tool to increase the supply of rental housing for low income households. It is funded with a share (currently 25 percent) of conveyance tax collections and legislative appropriations. The RHTF provides equity gap low-interest loans to qualified owners and developers for the development or preservation of affordable rental housing. HHFDC has awarded trust funds to assist in the development or preservation of 4,094 rental housing units since the establishment of the RHTF in 1992. Most RHTF awards are made to projects affordable to families at or below 60 percent of the area median income. The RHTF is currently oversubscribed, with project commitments and applications exceeding the available cash balance of the fund. The following RHTF information is as of January 31, 2011.

In addition to these commitments, HHFDC recently received new project applications for RHTF funds totaling an additional \$28,384,443, which are under staff review. Without infusions of continued conveyance tax revenues and legislative appropriations, the HHFDC will not be able to fund any of these new affordable rental projects. The executive budget includes a request for \$20,000,000 for the RHTF over the biennium (\$10M for FY2012 and \$10M for FY2013).

Information on rental housing projects financed through the RHTF is included in Appendix **E**.

The **Dwelling Unit Revolving Fund** (DURF), which was established in 1970, is a successful financing tool for the development of affordable housing. Funds may be used for the acquisition of real property; development and construction of for-sale and rental project and commercial and industrial properties that are integral to residential development; and all things necessary to carry out the purposes of the Housing Development Program, including administrative expenses. Since DURF is a <u>revolving fund</u>, it is primarily used for interim construction financing vs. long-term, permanent financing. From 1972 to 2010, DURF has helped to finance the development or preservation of nearly 15,000 for-sale and rental housing units statewide.

As of January 31, 2011, the DURF uncommitted/unencumbered balance was \$9,897,426.40. DURF's cash balance was \$107,887,736.86, with a state investment pool cash write-down to fair market value of \$6,155,866, and outstanding loan agreements and restricted funds totaling \$91,834,444.41 for projects listed on the next page.

Approximately 864 rental and for-sale housing units are estimated for delivery in this 2011 fiscal year. Over 1,000 housing units are estimated for completion in each of the ensuing fiscal years 2012 and 2013.












# Number of Supportive Housing Beds Available FY2003 – FY2011






# Number of Supervised Housing Beds Available FY2003 – FY2011 By County






# Number of Supervised Housing Beds Available FY2003 – FY2011 By County




## Number of Supervised Housing Beds Available FY2003 – FY2011 By County











#### AMHD Bed Vacancy Rates – Oahu 2008 - 2010






#### AMHD Bed Vacancy Rates Oahu 2008 - 2010








#### AMHD Bed Vacancy Rates – Hawai`i County 2008 - 2010




### AMHD Bed Vacancy Rates – Maui County 2008 - 2010












### AMHD Bed Vacancy Rates – Kaua`i County 2008 - 2010








# In consideration of HOUSING AND HOMELESSNESS

Chairpersons and Members of the Senate, thank you for the opportunity to provide you with comments regarding housing and homelessness in the State of Hawaii.

The Hawaii Public Housing Authority (HPHA) has been asked to provide information regarding several important factors that relate to the State of Hawaii's continuum of affordable housing and the agency's participation as a provider within that continuum. First, the agency will explain to the Legislature certain background facts concerning financial and demographic information used by the agency in carrying out our mission. Second, we will provide information concerning our unit counts, vacancy rates, and vacant unit turnaround time. We will discuss current and future plans for unit modernization and potential new construction of additional units. Finally, we will describe plans for increasing efficiency in the use of our properties.

The HPHA's current inventory of stock houses over 15,000 people in 6,195 public housing units (both State and Federal). As of February 2011, there were 423 vacant, non-rent ready units in the agency's portfolio, constituting approximately 93% occupancy rate for the State. This gap in occupancy is a direct result of the ongoing furloughs, hiring freezes, and reductions in force, which have resulted in a smaller number of staff handling a growing maintenance backlog as well as routine unit turnover. These budget impacts have also led to an increased vacated unit turnaround time exceeding three weeks per unit, far higher than the agency's stated target policy of 7 days.

The HPHA's primary mission is to provide affordable housing to this State's most vulnerable populations, such as those earning less than thirty percent of the Area Median Income (AMI), the disabled, and the elderly. Our definition of "affordable

housing" differs from other participants in this market because we only serve those earning less than 30% AMI, and by federal law, rents charged cannot exceed thirty percent of a family's adjusted gross income. Rents charged by the HPHA are incomebased, and are limited to 30% of the tenant family's adjusted gross income by law. In calculating adjusted gross income, qualified tenant expenses are deducted from their net income, and rents are assessed at the reduced amount and may not exceed 30%.

Area Median Income is determined by HUD annually and it varies nationally based on family size and metropolitan statistical area (MSA). The chart below illustrates the Honolulu MSA's AMI as determined by HUD for Fiscal Year 2010 and shows what a 30% rent for that income level would be:

The Department of Housing and Urban Development (HUD) also provides guidelines annually regarding fair market rents (FMR) that are instructive in assessing affordability for low and very low income populations. According to HUD, Fiscal Year 2011 Fair Market Rents for the State of Hawaii are as follows:

It is apparent by comparing the two tables that even families earning as much as 80% AMI are unable to afford market rents in Honolulu County for the appropriate sized unit.

A 2-person family earning \$50,514 should be limited to \$1,260 in rent, but the FMR for a 1 bedroom in Honolulu is \$1,396. According to data compiled in 2010 from the National Low-Income Housing Coalition (NLIHC), 65% of renters in the Honolulu MSA were unable to afford a two bedroom unit at fair market rent.<sup>1</sup>

The HPHA currently has a waitlist containing over 9,800 families, and of these, over 97% earn between zero and 30% AMI. The majority of these families have incomes based on fixed incomes, such as social security and disability benefits. According to the NLIHC dataset, supplemental security income payments for the State of Hawaii in 2010 were \$674 per month, translating to a maximum affordable monthly rent of \$202, assuming no allowable deductions to adjusted gross income.

This agency currently has an unmet capital needs backlog in excess of \$350 million, which was discovered in a 2007 Physical Needs Assessment. The modernization of our units is underway at several developments, notably at Kalihi Valley Homes, and is scheduled to begin at properties on Maui, and at Palolo Valley Homes and Puahala Homes. Despite the goal of complete modernization of all of our aging units, we have had difficulty meeting the capital need due to the budget constraints mentioned above, which have impacted staffing, as well as static capital improvement funding from the State. While the HPHA is planning new unit construction in the long term capital planning horizon (four to five years out), it would be irresponsible to undertake such developments in light of the current maintenance backlog. Within the short term capital planning horizon (less than three years), all capital funds are expected to be consumed by necessary modernization improvements.

The HPHA is also evaluating its property portfolio in order to determine locations for more efficient use of State property for public and affordable housing opportunities. While this would also be part of the agency's longer term planning horizon, an initial assessment indicates potential for at least one mixed use development containing commercial, mixed use, and government offices at the HPHA's administrative offices at 1002 North School Street. Further study will be required in terms of property and market evaluation.

The HPHA appreciates the opportunity to provide the Senate with information regarding our role in the affordable housing market in the State of Hawaii.
