Good morning Chair Hee, Vice Chair Shimabukuro and members of the Committee.

My name is Tom Farrell. I am an attorney and the chair of the Family Law Section of the Hawaii State Bar Association, on whose behalf I testify this morning.

The Family Law Section is comprised of over 125 attorneys who practice primarily in Family Court. We handle divorce, paternity, domestic violence, child protection and guardianship cases. As a Section, our testimony represents the views of our members only; we do not speak on behalf of the entire Hawaii State Bar Association.

Although we do not usually testify about judicial nominations other than to Family Court, we felt that we should submit testimony regarding Mr. Kupau because the press release announcing his nomination indicated that he had served as a per diem "District Family Court Judge." We were concerned that silence from the Family Law Section about a per diem Family Court judge might somehow be misconstrued against Mr. Kupau.

Although Mr. Kupau was appointed as a per diem judge for both District and Family Court, he has not actually served on the Family Court bench. As an attorney, he has not had significant involvement in family law, and accordingly, he is not well known among the members of our section. None of this should be held against him.

We certainly are not opposed to his nomination and note that Mr. Kupau brings an impressive resume to the District Court position to which he has been nominated. We wish him well and commend him for his willingness to serve the people of Hawaii.

He has coached youth athletics, which I can attest from personal experience, can be challenging at times but more rewarding and humbling, when you understand that you can have a positive impact with today's youth.


Last but not least he has been very empathic outlook and is very accountable for his actions. I feel he would be a great candidate for this respected position.
