## Testimony of Loretta J. Fuddy, A.C.S.W., M.P.H. Acting Director of Health

February 8, 2011 3:00 p.m.

- **Department's Position:** 1 The Department of Health appreciates the intent of this measure to reduce plastic bag waste, but respectfully opposes the measure at this time. 2 3 Fiscal Implications: The department estimates that the additional resources needed to plan, coordinate and implement this new ban would total approximately \$150,000, including 1.5 FTEs. There may be 4 added costs to consumers who switch to paper bags or other reusable bags. 5 Purpose and Justification: The bill prohibits businesses having annual gross sales of over \$300,000 as 6 7 of July 1, 2012 from distributing single-use plastic checkout bags to their customers, sets administrative fines, and encourages them to offer reusable bags for sale instead. 8 9 While the department generally supports the reduction of solid waste, litter, and the use of petroleum resources, we respectfully oppose this measure. The reduction of plastic bag waste through a 10 ban on single-use plastic checkout bags is prudent if adequate substitutes are available to the public. 11 12 However, the department believes a statewide ban is inappropriate at this time. The plastic bag
  - reduction ordinances for both Kauai and Maui County just took effect in early January 2011. These ordinances allow local businesses to charge customers for recyclable paper bags and other reusable bags.

1	The County of Hawaii has attempted to pass a similar ordinance without success. The department
2	prefers to let counties decide how to reduce use of single-use plastic checkout bags.
3	Passage of a statewide ban also means that the department will have to enforce the ban, conduct
4	outreach and education, and evaluate requests from businesses who claim undue hardship, with no
5	additional staff or other resources.
