RE: S.B. 1068; RELATING TO ANIMAL CRUELTY.

Chair Hee, Vice-Chair Shimabukuro, and members of the Senate Committee on Judiciary and Labor, the Department of the Prosecuting Attorney of the City and County of Honolulu submits the following testimony in support of Senate Bill 1068, along with a friendly amendment to the exception language.

The purpose of Senate Bill 1068 is to amend Hawaii Revised Statutes, Section 711-1108.5, to add "killing any pet animal belonging to another person" among the list of acts that constitute cruelty to animals in the first degree. This would also add an exception for the humane killing of any pet animal by an animal control officer, duly incorporated humane society, duly incorporated society for the prevention of cruelty to animals, or duly authorized governmental agency (underlined portion is suggested as a friendly amendment, for internal consistency).

In 2007, the Legislature enacted Section 711-1108.5, based--in part--on research indicating that violence against pet animals has a profound impact on pet owners and their families. Many pet owners form a close emotional bond and/or relationship with their pet animals, and consider their pets to be akin to a family member. Although the current language of Section 711-1108.5 clearly prohibits the torture, mutilation and/or poisoning of a pet animal, it does not expressly address any other methods of killing. For instance, if a pet animal is shot from close-range, stabbed in the heart, or otherwise killed instantly, it is unclear whether the perpetrator's actions would currently qualify under the definition of animal cruelty. This "loophole" must be closed immediately, and this type of behavior strongly discouraged.

For this reason, the Department of the Prosecuting Attorney of the City and County of Honolulu strongly supports Senate Bill 1068, with the friendly amendment indicated above. Thank you for the opportunity to testify on this matter.




I, Angela Kaaihue, support SB 1068.

I have had my goats stolen, and killed. People trespass at night, break in, and steal my animal livestock. I knew some of the suspects, but didn't have the proof. Harsher criminal penalties may have deterred thieves from stealing. I've also had neighbors who have threatened to kill my goats or animals if they wandered into their yard. I've requested for them to call and notify us, and we will remove the animal ourselves. But because KEENAN MINAMI, an employee of the STATE OF HAWAII, DEPARTMENT OF AGRICULTURE, his parents whom OWN agriculture land adjacent to mine has a GUN because of his employment, he has threatened to shoot and kill my harmless animals if they wandered into his parents yard. Even though he is OFF-DUTY.

The animals are harmless and are very scared of humans, so do not pose as a threat to humans, yet because of animosity between neighbors, he has threatened to shoot or kill my animals without my permission, because of other easement and trespassing issues they are accused of and in retaliation. Perhaps because Keenan Minami wants to justify a reason to use his gun, killing and shooting at my goats, even when they are on my property. This is animal cruelty and is no reason to shoot my goats!! My goats deserve the utmost respect and protection which would reflect Hawaii State Laws and Policies.

If people knew that killing animals, livestock, or stealing of them is to be considered a first degree offense, then perhaps people will think twice before stealing. If they are caught, then they will deserve the harsher punishment. Protecting our food sources and becoming self-sustaining and not so dependent on imported foods is essential and viable for our survival.

People who help strive to help Hawaii achieve these goals for Food Sustainability should be provided the necessary support to protect Hawaii's livelihood.
