RE: S.B. 1069; RELATING TO CRUELTY TO ANIMALS.

Chair Hee, Vice Chair Shimabukuro, and members of the Senate Committee on Judiciary and Labor, the Department of the Prosecuting Attorney of the City and County of Honolulu submits the following testimony in support of Senate Bill 1069.

The purpose of Senate Bill 1069 is to amend Chapter 711, Hawaii Revised Statutes, to create separate offenses for fighting dogs in the first and second degrees. With these amendments, fighting dogs in the second degree would include those who knowingly wager on or attend a "dog fight," within specific definitions of the term "attend," and fighting dogs in the first degree would encompass those involved in putting on a "dog fight" and/or handling the dogs.

The Department of the Prosecuting Attorney supports Senate Bill 1069's policy goal of decreasing or eliminating fighting dogs, which is a cruel and unacceptable activity, and further agrees with its goal to address "demand" as well as "supply" for the industry.

An issue is whether the law can punish a person who "attends" a "dog fight"? There is a Hawaii case that struck down an ordinance that penalized persons who merely attend a "chicken fight." In that case, the Supreme Court of Hawaii held that "An ordinance or statute proscribing presence, whether at a cockfight, a gambling game, or house of prostitution, is too vague to satisfy the requirements of due process." State of Hawaii v. Abellano, 50 Haw. 384, 386, 441 P.2d 333, 334, (Haw. 1968). The court further stated, "Unless the activity at which presence is unlawful is in a narrowly confined place, determination of what constitutes presence at the activity can be resolved only on the basis of policy." Id. at 334-335. The court explained that it

is a legislative function to make a clear policy determination in defining the activity in which presence is unlawful.

It is important to note that the Supreme Court of Tennessee held that a "Statute prohibiting persons from knowingly being present at a cockfight or similar exhibition, or at a place where preparations are being made for such an exhibition, is a valid exercise of police power and does not improperly infringe upon freedom of association, mobility or any other constitutionally protected right, and is reasonably related to the legislative purpose of discouraging and prohibiting the cruel practice of animal baiting and fighting, whether for gambling purposes or otherwise." State of Tennessee v. Tabor, 678 S.W.2d 45, (Tenn. 1984).

Similarly, Senate Bill 1069 proposes similar language of "knowingly attends or pays to attend a dogfight." Such language is more narrowly defined than just mere "presence" that was stricken down by the Supreme Court of Hawaii. <u>State of Hawaii v. Abellano</u>, 50 Haw. 384, 441 P.2d 333, (Haw. 1968).

The Court of Appeals of Oregon went further than the Supreme Court of Tennessee's decision to uphold "knowingly attend" as constitutional when it held that "statutes establishing the offense of attempted involvement in animal fighting are not unconstitutionally vague in violation of the Federal Due Process Clause or Article I, sections 20 and 21 of the Oregon Constitution." State of Oregon v. Hartrampf, 118 Or.App. 237, 239-240, 847 P.2d 856, 857 (Or. Ct. App. 1993).

Although the rulings by the Supreme Court of Tennessee and the Court of Appeals of Oregon are not binding authority in Hawaii as case law precedence, these rulings are persuasive should Senate Bill 1069 pass into law and get challenged in the Hawaii courts as a "case of first impression." However, the ultimate decision would still be in the hands of the Hawaii courts.

Based on the foregoing, the Department of the Prosecuting Attorney of the City and County of Honolulu supports Senate Bill 1069. Thank you for the opportunity to testify on this matter.

On behalf of our more than 49,000 members and supporters of The Humane Society of the United States in Hawaii, we thank you for this opportunity to speak in strong support of SB1069; and thank Sen Hee for his sponsorship of this critical crime and cruelty prevention measure.

Why this law is needed: In a recent national ranking of dogfighting laws, Hawaii ranked 50th with the weakest law, primarily because there is no penalty for attending or wagering on an organized dogfight. Under our existing law, one would need to be literally caught in the act of dogfighting, which, due to the clandestine nature of such activity, is extremely rare. If law enforcement were to encounter a dogfight in progress, under current law, knowing participants could claim they were mere spectators and face no penalty. Attendees provide much of the profit associated with dogfighting. The money generated by admission fees and gambling helps keep this "sport" alive. Because dogfighting itself is illegal, and therefore not widely publicized, attendees do not merely happen upon a fight, they seek it out; spectators are thus willing participants who support the continuation of this criminal activity.

In addition, the proposed bill would also add critical language relating to those who possess, breed, raise, sell or transport dogs for fighting purposes, including explicitly prohibiting the use of stray or stolen pets as "bait" to train fighting dogs. Under our current law, dogfighters could claim they only breed or sell fighting dogs and not be subject to any charges. Dogfighters could also claim they don't legally "own" the dog which can be difficult for law enforcement to establish.

In order to best address the deficiencies in our current law, and based on recommendations from the Honolulu Prosecuting Attorney's Office, we also request your consideration of the following amendments:

- Strike proposed definition of "attends" and instead amend Section 1 (b) to read: [knowingly] "Attends or pays to attend any place or building where a dogfight is taking place or preparations for a dogfight are taking place", which is based on similar "spectator/attendance" language found in other states such as Tennessee and Oregon, which the courts have upheld, and addresses "mere presence" concerns raised in past Hawaii case law.
- To address concerns raised by the Public Defender's office regarding penalties, amend Section 1 offenses to a misdemeanor and retain current class C felony for other acts.
- Add a severability clause, should any of these new provisions be challenged.

The 2007 Michael Vick case sadly exposed that no community is immune from dogfighting—a community that also believed that such activity was not occurring. In fact, it was strong anti-dogfighting laws, such as the proposed, that allowed Vick and his co-conspirators to be successfully charged and convicted. Our organization has assisted in hundreds of animal fighting raids across the country and we are sadly aware that dogfighting activity has and continues to occur in Hawaii.

Public Safety Issue:

Dogs used for fighting have been bred for many generations to be dangerously aggressive toward other animals. The presence of these dogs in a community increases the risk of attacks not only on other animals but also on people. Children are especially at risk, because their small size may cause a fighting dog to perceive a child as another animal.

Associated Crimes:

Dogfighting is also associated with other crimes such as illegal gambling, drug distribution and human violence. According to a study conducted by the Chicago Police Department, of more than 300 people arrested for crimes against animals (including dogfighting), more than 65 percent had also been arrested for battery-related violent crimes and 70 percent for illegal drugs.

Cruelty to dogs and "bait" animals

The injuries inflicted and sustained by dogs participating in dogfights are frequently severe, even fatal. Dogs used in these "events" often die of blood loss, shock, dehydration, exhaustion, or infection hours or even days after the fight. Other animals are often sacrificed as well. Some owners train their dogs for fights using smaller animals such as cats, rabbits or small dogs. These "bait" animals are often stolen or stray pets or animals obtained through "free to good home" advertisements.

This critical measure would bring Hawaii's law in line with the rest of the country and provide law enforcement with more comprehensive laws to investigate and charge those involved with illegal dogfighting. Furthermore, upgrading our law serves as a deterrent for those who may consider becoming involved in illegal dogfighting activity and sends a clear message to the community that dogfighting is a cruel and serious crime that will not be tolerated.

We respectfully urge your passage of SB 1069 to reduce crime, animal cruelty and to create safer communities for pets and people alike.

Dear Members of the Senate Judiciary and Labor Committee,

My name is Theresa Donnelly, and I am urging you to pass SB 1069, relating to dogfighting. Extending the current cruelty laws to punish those who attend dogfights is long overdue. A 2009 fact sheet from the Humane Society of the United States reveals that 48 States already consider being a spectator at a dogfight either a misdemeanor or felony. It is a travesty that in our State of aloha, a spectator can still legally attend or stage a dogfight.

It is no secret that those who attend dogfights are also associated with other illegal activities, such as drug dealing and illegal gambling. Anyone who enjoys this blood thirsty activity has no empathy for animals. This despicable practice is a stain to our humanity. Hawaii should be a place of compassion and pride. Our laws need to reflect a moral collective consciousness and passing this bill will demonstrate that.
