The civil legal needs of indigent crime victims in Hawaii are reaching critical proportions in the face of repeated funding reductions for the legal agencies providing services to this at risk population. The proposed increases, although nominal, are essential to the very existence of these programs.

Volunteer Legal Services Hawai'i submits this testimony in support of S.B. 1073, Relating to Surcharge for Indigent Legal Services.

S.B. 1073 raises the court filing fee surcharge and expands the surcharge to all District Court cases. Money from the surcharge is deposited into the Indigent Legal Assistance Fund (ILAF), which financially supports organizations that provide legal services to Hawaii's low-income population. Current recipients of ILAF funds are Domestic Violence Action Center, Hawai'i Disability Rights Center, Legal Aid Society of Hawai'i, Mediation Center of the Pacific, Native Hawaiian Legal Corporation, University of Hawai'i Elder Law Program, and Volunteer Legal Services Hawai'i.

Volunteer Legal Services Hawai'i (VLSH) provides free legal assistance to low-income individuals and families through volunteer attorneys. Like other legal service organizations, VLSH has experienced a substantial decrease in funding in recent years. At the time when many Hawai'i residents found themselves newly poor and in need of legal services to deal with changed circumstances, VLSH was forced to reduce its operations and was unable to assist hundreds of individuals and families.

As other funding sources continue to dwindle, ILAF has become increasingly important to legal service providers. The surcharge increases in S.B. 1073 will help these organizations meet the increased need for direct legal services. VLSH therefore respectfully requests your support of S.B. 1073.

Dear Chair Hee:

I am writing in support of the Indigent Legal Assistance Fund bill (S.B. 1073). I am a member of the Hawaii State Bar Association and have previously practiced law primarily as a federal attorney. When the Hawaii Access to Justice Commission ("Commission") was created, there was a call for volunteers to assist on various committees of the Commission. I volunteered because of the Commission's purpose.

As you are probably aware, the purpose of the Commission is to substantially increase access to justice in civil legal matters for low- and moderate-income residents of Hawai`i.

Each of us in Hawai`i has a stake in ensuring that all residents have equal access to justice. When access to justice is denied, justice becomes a mere illusion perceived as available only to those who can pay for it. Such a situation undermines a rule of law that is premised on the principle that all individuals stand equally before the law.¹

The November 2007 Access to Justice Hui report found that low-income residents have a tremendous unmet need for civil legal services. Only 1 in 5 low- and moderate-income Hawai'i residents have their legal needs met, and legal service providers are able to help only 1 in 3 of those who contact them for assistance.

The economic difficulties during these times touch everyone in this community. The statistics show that the number of people living below 125% of the federal poverty guidelines increased in Hawai'i. The total number of those earning less than \$31,692 for a family of four annually rose from 156,321 to 172,862 and those between 125-149% of the federal poverty guidelines increased from 38,499 to 45,392.

Funding for the legal service providers such as Domestic Violence Action Center, Hawai`i Disability Rights Center, Legal Aid Society of Hawaii, Mediation Center of the Pacific, Native Hawaiian Legal Corporation, University of Hawaii Elder Law Program, and Volunteer Legal Services Hawaii that provide civil legal services to the low-income residents have been severely reduced. The passage of the subject bill is needed in order that legal assistance can be provided to these indigent people and families who have housing, family, income, and other critical issues.

Since being involved with the Access to Justice Commission, I have become acquainted with the unique individuals who "walk the talk" at the aforementioned legal service organizations. Although the financial obstacles are significant, they continue to help the underserved, because these individuals and providers are dedicated and committed to the ideals of justice. The approval of the subject bill will be acknowledgment that equal justice is important and the courtroom doors should be open to everyone in legitimate need.



The surcharge fees being proposed would not only be a significant increase but would be extended to thousands of new cases. In the District Court, for example, the surcharge on summary possession cases would go up 350% and would cover a new class of cases that number of 20,000 annually. In Circuit Court and courts of appeal the surcharge would increase by 260%. Remember the surcharge is not a one time fee, but a fee that can be charged multiple times in the same case. This is because the surcharge applies to the filings of cross claims, counter claims and third party complaints. Should any of those events occur in a case and they often do, the surcharge is again collected. What a hardship on all the parties.

Also, for small businesses which seek to gain access to the court system, such a hike will result in taking much-needed resources away from our local businesses, inevitably causing them to reduce wages, lay off workers, file for bankruptcy relief or even worse, close their doors entirely.

I humbly urge you to not support this legislation at this time.

The current filing fees in District and Circuit Courts are \$120.00 and \$275.00 respectively. To increase the indigent fee from \$10.00 to \$35.00 in District Court and from \$25.00 to \$65.00 in Circuit Court will place undue burden on those utilizing the court system to resolve legal disputes.

Anytime filing fees are increased, it creates barriers that may prevent some, especially those who already can least afford to seek access to our justice system, from having access, which is not only unfortunate—it is wrong. Making the court system less accessible will not benefit the parties by any means.
